	Statistics Wales quarterly update SH noted the following: COVID-19 has continued to have an impact but a number of data collections and publications that were paused are now returning to more normal publication timescales We will continue to review the frequency and content of data on COVID-19, such as hospitalisations and care homes Colleagues in economic stats are considering making changes to existing outputs/stopping them e.g. short term output indicators. They would like people's feedback on these plans. The school census date is 15 February, which was delayed due to Covid Note that National Survey for Wales team are considering survey approaches for the future, following the change from face-to-face data collection during the pandemic Some Welsh language statistical profiles are being developed. Members to get in touch if interested in providing feedback on the draft profiles.	
	SL confirmed outputs likely to be in line with timing in previous (pre-pandemic) years JE suggested that data being used for Local Housing Market Assessments could potentially be used more widely and suggested this could be an agenda item for a future meeting.	
	Demography update Update included note on LAs being invited to take part in Census quality assurance (QA). SH noted that all but five LAs are involved	

in the QA of the census at local authority level so far. Other LAs are encouraged to consider being involved.AW noted the situation in Anglesey and RJ (RCT) indicated she would liaise with Merthyr Tydfil BC.

Data Cymru update

SS highlighted that there is training coming soon e.g. on capacity building. SS is happy to talk to anyone interested in this.

Census update

Written update on Census 2021 outputs consultation provided. SH confirmed that late May is intended to be the first release date.

3. Race Equality Action Plan & Equality Data Unit / Race Disparity Unit for Wales – Catrin Awoyemi and Becca Sarasin, Welsh Government

CA and BS introduced themselves as joint Heads of the Equality, Race and Disability evidence units.

A of lack of evidence about inequalities has been intensified by the covid-19 pandemic. Scoping work took place in the last year which has led to creation of the three new units. CA provided an overview of work already done to develop the units and their structure (e.g. what is covered in each unit, which policy areas are covered), noting that commitments relevant to improving evidence are included in a number of Welsh Government Action plans. She provided an overview of upcoming work within units and the how they were engaging stakeholders. They are currently undertaking an evidence audit of what is available and the gaps. She covered what they are doing now to plan for improved evidence, and the anticipated challenges with the work. Recruitment to the units is ongoing.

BS mentioned that the team is multi-disciplinary, so covers social research, statistics and policy.

Discussion:

LR asked about what geographical level the units will cover and VD noted that LA level data would be valuable. CA said they would consider this because they want to take into account what stakeholders want.

MC noted interest in discussing ONS's current admin data equalities work with CA and BS to avoid duplication and to maximise the benefits of their work.

RJ (RCTCBC) noted that it will be important to understand inequalities for those with multiple protected characteristics. CA and BS are conscious of this and will make sure that analysis of intersectionality will be included in their plans.

RJ also asked if there was a recruitment page for interested parties. BS noted this as a good idea but said that currently roles were advertised on the Welsh Government website. Current vacancy (closes 24 March 2022):

SH mentioned a Chwarae Teg event on Tues 8 February entitled 'Why equality data matters'.

4. Well-being of Future Generations updates – Steph Howarth, Andrew Granville and Rob Morgan, Welsh Government

SH gave an update on national indicators following the consultation which took place on national milestone and indicators last autumn, and which was discussed at the previous WSLC. Some new national indicators have been agreed with include:

- % of people who have confidence in the justice system,
- % of journeys by walking, cycling or public transport,
- % of households spending 30% or more of income on housing costs,
- status of digital inclusion.

Where data is available, these will be included in the Wellbeing of Wales report later this year. Data sources are not yet available for some new indicators. For example, a new travel survey will help to measure the indicator on journeys.

AG gave an update on national milestones. The first nine milestones were agreed in December 2021, with some small changes introduced following the consultation. A second wave of national milestones are being developed this year. A wide range of areas are being covered including healthy life expectancy, mental well-being, income poverty and biodiversity. There will be a formal consultation in the summer and the final national milestone values will be agreed before the end of the year.

JE mentioned that there are no milestones focusing on housing issues. SH said the next wave of milestones will include energy efficiency of housing, and that there are a wider range of national indicators on housing. There was some discussion of the need for interim milestones. AG indicated that there were already some interim milestones in place for a couple of the indicators.

RM gave an update on the future trends report and noted that the latest report was published in December 2021. The report contains a narrative summary, evidence pack and infographics. The report is broken down into four mega trends which are:

- people and population
- inequalities and opportunities
- planetary health and limits
- technology evolution.

They have created a Shaping Wales' Future blog. In 2022 they will focus on looking at the longer term impact of Covid-19 on the

wellbeing of Wales and supporting Public Service Boards in translating Wellbeing Assessments into Wellbeing Plans.

The following discussion centred around the timing of reports, support for identifying data sources and how to interpret the trends particularly in the light of the Covid-19 pandemic. It was recognised that an earlier future trends report would be beneficial in future.

Transforming our population, migration and social statistics system – Michael Cole and Vicky Staples, Office for National Statistics

MC covered ONS's ambitions and current progress in transforming approaches to population and social statistics. More frequent estimates of population required and they are starting a radical approach to work towards achieving this. He showed a timeline of the transformation work. The aim is to provide more detailed and frequent outputs on population and migration, and embed these into official statistics.

Two case studies were shared – producing admin-based population estimates, and developing admin-based social statistics (including income stats, housing and ethnicity). MC gave an overview of topics that cannot readily be covered by admin data. Work is being done to consider how such topics can be covered in future either through admin data or through large surveys.

VS covered what is coming up in the next year – including census results and experimental stats for 2021 and 2022. They also want to engage with users on future outputs and recommendations.

Discussion:

JE asked about mid-year population estimates and whether there is a date yet for release of rebased estimates for 2012-2020. And if LA level 2021 data is due Sep 2022 when are Small Area Population Estimates (SAPEs) likely to be released? VS said mid-year population estimates for 2021 will be released in September 2022 with rebased population estimates at LA level in early 2023. She will find out when the SAPEs are likely become available and let the group know.

JE asked what data is available that helps with outputs for Wales as some admin based stats at the moment only cover England. VS said access to some data is limiting the analysis currently (only for England) and they are trying to work with WG and Digital Health and Care Wales to access data for Wales. This includes looking to use School census and HE data. MC said they are aiming to have data available for both nations when all outputs are released.

SK asked if the next update of admin-based population estimates will line up with census outputs. MC said it will be close to end of 2022. SK also asked for clarity around range of available labour market stats as they can be confusing. MC said they are trying to

make navigation accessible and easier for users to understand, but they are always keen to receive some feedback. JE noted the importance of the data we get from the Census about housing when they are looking at admin-based outputs. SL agreed this was important. MC said one of their key research areas for the 2023 recommendation is for housing, so it is in their scope to capture that as detailed as possible. Paycheck Data – Duncan Mackenzie, Data Cymru and Rhiannon Jones, Welsh Government DM explained that they run a consortium that allows LA to access to CACI Paycheck data on income with a discount if they commit to three years. The current three year deal is coming to an end. They are now in positon to review what the data has been used for. They believe the main use of data is in housing departments, but it may be used more widely across LAs. Discussion is ongoing with the WG about the income data to be used for Local Housing Market Assessments. RJ (WG) explained the new bilingual Local Housing Market Assessment (LHMA) Tool being developed.
