Updated version of my response for info etc etc.

Dear Angela, I hope this email finds you well.

Thank you for a copy of the email addressed to Lowri Norrington-Davies. I will use this opportunity to update you on matters raised recently in other emails.

I feel Stuart's and your passion about Fairbourne and how important it is for you both and ACC to do the right thing for the community in the face of the stark and difficult reality of living with sea level rise between now and 2054. Fairbourne is unfortunately situated in a very vulnerable coastal and estuarine environment and Stuart, you and ACC feel the financial pressures which is an obstacle to ensuring community cohesion in the longer term. I acknowledge ACC desire, to see things happening. My view is that incremental progress is been made as discussed below.

As much of what we knew as normal has changed, I do feel that we need more conversations in future. I assure you that after a 7 year involvement with the community, it is not my intention to distance myself from the issues and challenges you face.

Returning to the financial challenges is it now the time to create a fund from contribution from each body that is part of the Fairbourne Facing Forward Project Board (**FMFPB**)? Gwynedd Council would contribute an appropriate sum, equivalent to other board members' contributions if this was the case.

To recap, and as you know, the Council responses has to act in a manner that is consistent with the following:

- Flood and Water Management Act 2010
- Environment Wales Act 2016
- The National Strategy for Flood and Coastal Erosion Risk Management in Wales 2020
- Local Flood Risk Management Strategy
- NRW flood risk maps
- Shoreline Management Plan 2
- Welsh Government: A Climate Conscious Wales which states that some communities may become unsustainable in the longer term due to sea level rise.

In the period from 2013 to January 2020 Gwynedd Council chaired the multi-agency board which included the following organisations - Gwynedd Council, NRW, Arthog CC (ACC), Fairbourne Facing Change (no longer in existence) Snowdonia National Park, Network Rail, Royal HoskoningDHV, Welsh Water and Welsh Government. Attendance level at project board meetings has actually been variable and, due to our consistent attendance, in many ways has been perceived as a Gwynedd Council board. This is clearly not the case. As we know the detail on "Fairbourne: the story so far" is contained in the "Fairbourne: a framework for the future" document (pages 14 & 15") and demonstrates the complexity of the challenges we face.

During this period Gwynedd Council spent in excess of £220k on this project, in addition to substantial WG grants, as I had to report to the Cabinet in Autumn 2019.

Moving forward to the recent past, during 2019 – 2020 I believe there have been several developments, which I will summarise below:

- The multi-agency board obtained a Masterplan largely prepared by Royal HoskoningDHV. This document was found to be too complicated a document for public consumption. It is however a valuable technical reference document which is available to ACC.
- The multi-agency board simplified the contents and produced a "Fairbourne: a framework for the future" document. (copy attached). This document consolidated the then current position and suggested a "framework of workstreams" to tackle different elements of this complicated project. I am sad to hear that you felt divorced from the preparation of this document. One aim we, the Fairbourne Facing Forward Project Board (FMFPB), had was to have SP Energy, Dwr Cymru NHS Wales as key partners for the future.

- It was envisaged that the chair of each workstream (where key tasks would be addressed in terms of actions and risk) would report directly to the multi-agency board (FMFPB). The Framework was designed to be a live document that could be amended in line with the rate of climate change. There were discussions on having a project manager to be put in place to co-ordinate workstream matters, subject to funding. Finance for this post has not been identified.
- Consultation on the "Fairbourne: a framework for the future" document was carried out in October 2019 at the Fairbourne village hall. I viewed this as a key moment in terms of progress.
- A report on the responses was prepared and made available to ACC late 2020 (copy attached). The document is yet to be finalised until it is discussed fully by the FMFPB. This report could well amend the work to be completed by the workstreams. Can this be an item at the next Board meeting?
- I attended your ACC meeting on 9/1/20 and the email exchanges in my opinion demonstrates a high level of understanding and support at that point in time (copy attached).
- Gwynedd Council through me suggested in January 2020 that this was a timely junction for Gwynedd Council's chairing of the FMFPB to stop and for a new chair to be appointed. This person would bring new energy and perspective to matters that needed attention. This change was approved and Stuart Eaves of ACC became the new chair. (copy of minutes attached). Also the role of two Community Ambassadors were approved at this meeting.
- At various FMFPB meetings the role of the PSB, in terms of governance and who makes the
 decision (and when) to decommission the community have been discussed. This matter is
 still ongoing and has been discussed with Gwynedd Council's Chief Executive.
- Construction work at Friog Corner (value at some £1.5M) and more recently moving 20,000 tonnes of shingle on Fairbourne beach (to fill in an eroded area in front of the village) has now been completed by NRW.
- The Fairbourne Internal Gwynedd Council Project Board was set up to ensure a corporate
 response to issues especially as Gwynedd leads on workstream 1, 2 and 4, with ACC leading
 on workstream 3 and the community engagement work, and NRW leading on workstream 5.
 ACC now knows which department is leading each workstream and in some cases also the
 lead officer name. This demonstrates Gwynedd Council's support to the community.
- I have also informed you that further internal meetings are required to discuss workstream 2 topics, due to the complexity of the subject matter. Actions relating to workstream 4 will receive attention when resources are released from dealing with Covid19 challenges the ramp issues having already been addressed by Barry Davies. Lindsey Ellis Edwards is the Community Support Services Manager and she is aware of her role as part of the Economy and Community Department.
- FMFPB September 2020 meeting: As we know, public bodies' staff have to think carefully before attending face to face meetings. That is why the preference is for Teams or Zoom meetings. However, Rob Williams, a member of the YGC management team, is well qualified to attend the meeting on my behalf and is also the lead member on Workstream 1.
- Cllr Catrin Wager, as a Cabinet Member, is leading on the assessment of the consequences of climate change within Gwynedd and the impacts of recent flooding incidents.
- Correspondence with Sophie Howe the Future Generations Commissioner; this matter will be discussed by the Chief Executive at the next PSB meeting.
- A copy of the "The National Strategy for Flood and Coastal Erosion Risk Management in Wales"; was shared with ACC via a community ambassador.
- Gwynedd Council made a £40k bid to Welsh Government for investigating the
 decommissioning options. This was successful and an Outline Business Case (OBC) now
 needs to be produced. This work is yet to start as Gwynedd Council resources are stretched

due to Covid19 and the February 2020 floods (Storm Dennis) pressures. This work needs to be discussed with the FMFPB and it is likely to be completed by a private sector consultant. The OBC would need GC/ WG / FMFPB sign off. This can be discussed at the next Board meeting. In the meantime (as a parallel activity **and part of the grant**) the previous CIC submission, following Welsh Government and Cllr C Wager discussions, needs to be updated and amended for resubmission to WG. This has, to date, been referred to as CIC2. Again the Covid19 emergency has prevented much progress to date – but, in the interest of clarity, the original incarnation of CIC intended for some 20 properties to be purchased and becoming holiday properties with a 15 year payback period; the financial risk being with Gwynedd Council. If you agree I would like to discuss this matter further at the next Board meeting.

• Gwynedd Council note that the Chair needs the support of Steff Jones for workstream 3 (chaired by ACC). This is consistent with what was agreed. Gwynedd Council is however not responsible for the attendance of other public and private sector bodies.

I apologise for the length of response, but it has proven positive in the past to cover items in appropriate detail. In conclusion I would restate that Gwynedd Council will continue to support the FMFPB where possible, as one of the private / public bodies on the Project Board.

Fairbourne is unfortunately a vulnerable coastal and estuarine community in an environment particularly susceptible to flooding, and as such the Council is guided by the following in terms of a response:

- Flood and Water Management Act 2010
- Environment Wales Act 2016
- The National Strategy for Flood and Coastal Erosion Risk Management in Wales 2020
- Local Flood Risk Management Strategy
- NRW flood risk maps
- Shoreline Management Plan 2
- Welsh Government: a climate conscious Wales which states that some communities may become unsustainable in the longer term due to sea level rise.

In the period from 2013 to January 2020 Gwynedd Council chaired the multi-agency board which included the following organisations - Gwynedd Council, NRW, Arthog CC (ACC), Fairbourn Facing Change (now not in existence) Snowdonia National Park, Network Rail, Royal HoskoningDHV, Welsh Water and Welsh Government.

As you state the attendance level was variable and in many ways this was seen as a Gwynedd Council Board (due to our consistent attendance); which is clearly not accurate or correct. More detail on "Fairbourne: the story so far" is contained in the "Fairbourne: a framework for the future document (pages 14 & 15"). In this period Gwynedd Council spent in excess of £220k on this project, in addition to substantial WG grants, as reported to the Cabinet in Autumn 2019.

Moving forward to the recent past, 2019 – 2020 there have been several developments, summarised below:

- The multi-agency board obtained a Masterplan largely prepared by Royal HoskoningDHV. This document was found to be a complicated document for public consumption

- At the FMFPB meetings the role of the PSB role, in terms of governance and who makes the
 decision (and when) to decommission the community have been discussed. This matter is
 still ongoing.
- Costruction work at Friog Corner (value at some £1.5M) and more recently moving 20,000 tonnes of shingle on Fairbourne beach (to fill in an eroded area in front of the village) has been completed by NRW.
- The Fairbourne Internal Gwynedd Council Project Board was set up to ensure a corporate response to issues - especially as Gwynedd leads on workstream 1, 2 and 4, with ACC leading on workstream 3 and the community engagement work, and NRW leading on workstream 5.

- In terms of funding the FMFPB, Gwynedd Council would contribute an appropriate sum, equivalent to other board members contributions.
- ACC have been informed that further internal meetings are required to discuss workstream 2 topics, due to the complexity of the subject matter. Actions relating to workstream 4 will receive attention when resources are released from dealing with Covid challenges – the ramp issues having already been addressed by Barry Davies. Lindsey Ellis Edwards is the Community Support Services Manager and she is aware of her role as part of the Economy and Community Department.
- FMFPB September 2020 meeting. As we know public bodies staff have to think carefully before attending face to face meetings. That is why the preference for Teams or Zoom meetings. However Rob Williams as a member of the YGC management team is well qualified to attend the meeting on Huw Williams's behalf and is the lead member on Workstream 1.
- Gwynedd Council also informed ACC that Cllr Catrin Wager, as a Cabinet Member, needs to address the consequences within Gwynedd of wider climate change impacts.
- Correspondence with Sophie Howe the Future Generations Commissioner, this matter will be discussed at the next PSB meeting.

- A copy of the "The National Strategy for Flood and Coastal Erosion Risk Management in Wales"; was shared with ACC via a community ambassador.
- Gwynedd Council made a £40k bid to Welsh Government for investigating the decommissioning options. This was successful and an OBC now needs to be produced. This work is yet to start as Gwynedd Council resources are stretched on Covid and the February 2020 floods (storm Dennis) matters.
