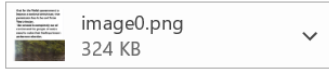

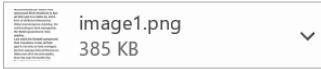
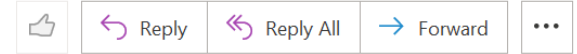

I would be very grateful for your response.

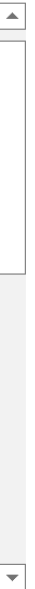
