As a side note, the Club planted 13,800 trees at the end of last year - that's one tree for every member of the Club.

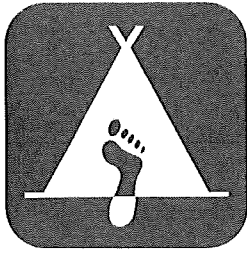
