

## DEDDF CYNLLUNIO GWLAD A THREF 1990

### GORCHYMYN CAU PRIFFYRDD (4 BRYN GOFAL, LLANGRISTIOLUS, YNYS MÔN) 2022

Mae Gweinidogion Cymru wedi gwneud Gorchymyn o dan adran 247 o Ddeddf Cynllunio Gwlad a Thref 1990 ("Deddf 1990") i awdurdodi cau'r darn o briffordd a ddisgrifir yn Atodlen 1 i'r Hysbysiad hwn. Nid awdurdodir cau'r briffordd ond er mwyn gwneud y datblygiad yn unol â'r caniatâd cynllunio a roddwyd o dan Ran 3 o Ddeddf 1990 gan Gyngor Sir Ynys Môn ar 13 Rhagfyr 2021 o dan y cyfeirnod FPL/2021/279 a ddisgrifir yn Atodlen 2 i'r Hysbysiad hwn.

## TOWN AND COUNTRY PLANNING ACT 1990

### THE STOPPING UP OF HIGHWAYS (4 BRYN GOFAL, LLANGRISTIOLUS, ANGLESEY) ORDER 2022

The Welsh Ministers have made an Order under section 247 of the Town and Country Planning Act 1990 ("the 1990 Act") to authorise the stopping up of the length of highway described in Schedule 1 to this Notice. The stopping up is authorised only in order to enable the development to be carried out in accordance with planning permission granted under Part 3 of the 1990 Act by Isle of Anglesey County Council on 13 December 2021 with reference number FPL/2021/279 described in Schedule 2 to this Notice.

The Stopping Up of Highways (4 Bryn Gofal, Llangristiolus, Anglesey) Order 2022 ("the Order") ceases to have effect if planning permission in respect of the development expires or is revoked.

Copies of the Order and the deposited plan may be inspected free of charge during normal office hours from the Planning Department at Anglesey County Council Offices, Llangefni, Anglesey LL77 7TW. If a person is aggrieved by the Order, on the ground that:

- it is not within the powers of the Act; or
- a procedural requirement of the Act has not been complied with;

that person may, within 6 weeks of 27 May 2022 make an application for the purpose to the High Court.

**Length of highway to be stopped up**

A triangular shaped length of highway measuring approximately 18 square metres, located on the verge of the property known as 4 Bryn Gofal at Llangristiolus, Anglesey and shown by zebra hatching on the deposited plan.

**SCHEDULE 2**

**The Development**

To allow part of the highway verge outside 4 Bryn Gofal, Llangristiolus, Anglesey to form part of the residential curtilage of 4 Bryn Gofal.
