GORCHYMYN CAU PRIFFYRDD (TIR WRTH RHYDLAFAR DRIVE, SAIN FFAGAN, CAERDYDD) 2022

Mae Gweinidogion Cymru wedi gwneud Gorchymyn o dan adran 247 o Ddeddf Cynllunio Gwlad a Thref 1990 ("Deddf 1990") i awdurdodi cau'r darn o briffordd a ddisgrifir yn Atodlen 1 i'r Hysbysiad hwn. Nid awdurdodir cau'r briffordd ond er mwyn gwneud y datblygiad yn unol â'r caniatâd cynllunio a roddwyd o dan Ran 3 o Ddeddf 1990 gan y Cyngor ar 5 Hydref 2021 o dan y cyfeirnod 20/02634/MNR a ddisgrifir yn Atodlen 2 i'r Hysbysiad hwn.

TOWN AND COUNTRY PLANNING ACT 1990

THE STOPPING UP OF HIGHWAYS (LAND AT RHYDLAFAR DRIVE, ST FAGANS, CARDIFF) ORDER 2022

The Welsh Ministers have made an Order under section 247 of the Town and Country Planning Act 1990 ("the 1990 Act") to authorise the stopping up of the length of highway described in Schedule 1 to this Notice. The stopping up will be authorised only in order to enable the development to be carried out in accordance with planning permission granted under Part 3 of the 1990 Act by the Council on 5 October 2021 with reference number 20/02634/MNR described in Schedule 2 to this Notice.

The Stopping Up of Highways (Land at Rhydlafor Drive, St Fagans, Cardiff) Order 2022 ("the Order") ceases to have effect if planning permission in respect of the development expires or is revoked.

Copies of the Order and the deposited plan may be inspected free of charge at Cardiff Central Library, The Hays, Cardiff CF10 1FL or may be obtained free of charge from the address below quoting reference qA1479133.


If a person is aggrieved by the Order, on the grounds that:

- a. it is not within the powers of the 1990 Act; or
- b. a procedural requirement of the 1990 Act has not been complied with;

that person may, within 6 weeks of 4 May 2022 make an application for the purpose to the High Court.

Length of highway to be stopped up

An irregular shaped length of highway located to the east of the junction from the A4119 Llantrisant Road leading to Rhydylafar Drive, Cardiff, for a total area of 3367 square metres, and as shown on the deposited plan by zebra hatching.

SCHEDULE 2

The Development

Construction of a new 2 storey Medical Centre, Pharmacy, parking, landscaping and associated works.
