ATISN 16438 - Serious Untoward Incident Report

Thank you for your request to the Welsh Government for information under the Freedom of Information Act (2000) (FOIA) received on 28 June 2022 relating to a serious untoward incident report that occurred at Wrexham Maelor Hospital. You have requested the following recorded information:

 A copy of the Serious Untoward Incident Report in relation to the incident whereby a patient suffering with coeliac disease died after been given food containing gluten at Wrexham Maelor Hospital

You have also requested that we respond to the following questions:

- Does food containing gluten constitute a substance hazardous to health for people with Coeliac Disease, under the Control of Substances Hazardous to Health Regulations 2002 (COSHH)?
- Did Wrexham Maelor Hospital and Deeside Community Hospital carry out a suitable and sufficient risk assessment, as required by COSHH and the Management of Health and Safety at Work Regulations 1999?
- Did the hospitals implement appropriate robust control measures to protect patients with food hypersensitivity and ensure that the risks to their health and safety were as low as reasonably practicable?
- Did the hospitals implement procedures based on the Hazard Analysis & Critical Control Point (HACCP) principles, together with the application of good hygiene and safety practice, to meet the requirements of Regulation (EC) No 852/2004 on the hygiene of foodstuffs?
- Did the hospitals provide such information, instruction, training, and supervision as is necessary to ensure, so far as is reasonably practicable, the health and safety at work of his employees [hospital staff] – Health and Safety at Work etc Act 1974 Section 2(2)(c)
- The incident that occurred at Deeside Community Hospital resulted in a member of the public being taken to a different hospital for treatment. The incident that occurred at Wrexham Maelor Hospital contributed towards the death of a member of the public. Both appear to be RIDDOR reportable. Did the hospitals report the incidents, as required by the Reporting of Injuries, Diseases and Dangerous Occurrences Regulations 2013 (RIDDOR)?
- What plans do you have to take enforcement action at Betsi Cadwaladr University Health Board (the hospitals), including possible prosecution?
