Information requested

Thank you for your request which I received on 1 August 2022. You asked for information on the total cost of the now dissolved [Special Purpose Committee on Senedd Reform](#) to the Welsh Government. In your request you asked for all of the associated costs, from research to report compilation.

Our response

The Special Purpose Committee on Senedd Reform was established by the Welsh Parliament, and supported by the Senedd Commission. The Senedd Commission is a wholly independent organisation to the Welsh Government. Consequently, the overarching arrangements for supporting the Committee were of zero financial cost to the Welsh Government.

On 9 February 2022, the Counsel General and Welsh Government officials attended one informal meeting of the Committee to provide a technical briefing to the Committee's members. However, the Welsh Government does not hold information on the staff time-costs involved in preparing for and attending one meeting.

Next steps

If you are dissatisfied with the Welsh Government's handling of your request, you can ask for an internal review within 40 working days of the date of this response.
