Thank you for your request which I received on 20 July 2022. You asked for the following: information for each and every Welsh Government Ministerial car (without disclosing registration e.g. label as car 1, car 2):

- 1. Make and model
- 2. Add-ons (built in sat-nay, for instance)
- 3. Number of journeys over each of the last 5 years
- 4. Cost paid
- 5. Vendor
- 6. Mileage now vs mileage when purchased.

The information you have requested in relation to questions 1,2,4,5 & 6 is shown in the table below.

Regarding question 3. Your request as currently submitted will exceed the appropriate limit set out in the Freedom of Information and Data Protection (Appropriate Limit and Fees) Regulations 2004 to answer your request. The appropriate limit specified for central government is £600. This represents the estimated cost of it taking over 24 hours of time to determine whether we hold the information and to thereafter locate, retrieve and extract it.

The information would have to be compiled by extracting the information from daily vehicle logsheets. This would involve extracting data from a minimum of 9,000 individual records. I estimate that allowing 30 seconds to locate, retrieve and extract the data, would take a total of 74 hours which exceeds the appropriate limit.
