Cynorthwyo dysgwyr i wneud cynnydd yn BSL a thrwy BSL.

2. Amcanion

Cynhyrchu adnodd sydd yn cyflwyno elfennau o BSL i ddysgwyr byddar, er mwyn galluogi'r dysgwr i wneud cynnydd yn BSL. Bydd angen i'r deunyddiau ddefnyddio amrywiaethau rhanbarthol Cymreig o BSL (gan roi ystyriaeth i amrywiadau gogledd a de Cymru hefyd).

Bydd yr adnodd yn cydfynd â'r [disgrifiadau dysgu](#) a [canllawiau BSL y Cwricwlwm i Gymru](#).

3. Gofynion

Bydd yr adnodd yn cynnwys cyfres o glipiau fideos fydd ar gael o fewn un pecyn cynhwysfawr ar Hwb.

Rhaid defnyddio cyflwynydd byddar sy'n rhugl yn BSL i gyflwyno'r clipiau fideo, ac fe ddylai'r cyflenwr llwyddiannus gydweithio gyda'r gymuned fyddar ac eraill gydag arbenigedd ieithyddol BSL wrth ddatblygu'r adnodd.

i. Gofynion cynnwys:

- Bydd angen cyfres o glipiau fideo ar Hwb, gyda chyflwynydd/cyflwynwyr byddar sy'n rhugl yn BSL yn cyflwyno cynnwys y clipiau fideo unigol.
- Bydd angen delwedd yn y cefndir ar gyfer pob fideo er mwyn cyfleu yr hyn sy'n cael ei arwyddo. Ble na bo hyn yn bosib dylid cael opsiwn i ddangos y gair yn Gymraeg ac yn Saesneg ar sgrin ar gyfer yr athro/rhiant – bydd y cyflwynydd yn cyfleu'r ystyr trwy arwyddo hefyd. Fel isafswm bydd angen i'r adnodd gynnwys y canlynol:
 - Llythrennau'r wyddor Gymraeg (1 fideo i bob llythyren)
 - Llythrennau'r wyddor Saesneg (1 fideo i bob llythyren)
 - Lliwiau
 - Rhifau. Bydd angen 3 fideo:
 - fideo yn cyflwyno'r rhifau 1-10
 - fideo yn cyflwyno rhifau 11-20
 - fideo yn cyflwyno rhifau 30, 40, 50, 60, 70, 80, 90, 100, 1000)
 - Arwyddion/ymadroddion cyffredin (os gwelwch yn dda; diolch; mae'n ddrwg gen i; mae hynny'n ddiddorol; eto plis; byddar; clyw; wedi byddaru (deafened);
 - Arwyddion sy'n gysylltiedig â gwyliau a dathliadau (er enghraifft y Nadolig, Pasg, gwyliau crefyddol eraill, blwyddyn newydd, penblwydd)
 - Arwyddion ysgol (ysgol, neuadd, dosbarth, iard, athro, amser egwyl/chwarae, cinio, gwasanaeth, adeiladu, chwarae rôl, llyfr, paent, glud, stori/amser stori)
 - arwyddion deunyddiau naturiol (dail, brigau, moch coed, tywod, dŵr)
 - Cyfarchion (helo, bore da, p'nawn da, noswaith dda, nos da, croeso)
 - Brawddegau a chwestiynau syml
 - Teimladau/emosiynau (sut wyt ti?, hapus, cyffrous, trist, ofnus, pryderus)

- Dylid darparu costau am 2 weithgaredd rhyngweithiol ar gyfer pob topig fydd yn fodd o brofi ac atgyfnerthu dealltwriaeth y dysgwyr. **Yn ystod y broses o ddatblygu'r adnodd gall y bydd ymarferwyr yn gweld yr angen am ragor o weithgareddau a chynnwys - gofynnir i chi felly gynnwys cost ar wahân am bob gweithgaredd ychwanegol, yn ogystal â chost ar wahân ar gyfer creu fideos ychwanegol. 1. Aim

Support learners, enabling them to make progress in and through BSL.

2. Objectives

Produce a resource that introduces elements of BSL to deaf learners to enable the learner to make progress in BSL. The materials will need to use Welsh regional BSL variation (taking into account of the variations of north and south Wales).

The resource will need to be in line with the descriptions of learning [Descriptions of learning - Hwb \(gov.wales\)](https://hwb.gov.wales/curriculum-for-wales/languages-literacy-and-communication/designing-your-curriculum/#british-sign-language-(bsl)) and BSL guidance for Curriculum for Wales [https://hwb.gov.wales/curriculum-for-wales/languages-literacy-and-communication/designing-your-curriculum/#british-sign-language-\(bsl\)](https://hwb.gov.wales/curriculum-for-wales/languages-literacy-and-communication/designing-your-curriculum/#british-sign-language-(bsl))

3. Requirements

The resource will include a series of video clips available in one comprehensive package on Hwb.

A deaf presenter who is fluent in BSL must present the videos, and the successful supplier should work with the deaf community in Wales and others with specialist BSL linguistic knowledge when developing the resource.

i. Content requirements:

- A series of video clips on Hwb. Each individual video must be presented by a deaf, BSL fluent presenter/presenters.
- An image is required as background for each video in order to convey what is being signed. Where this is not possible, there should be an option to display the word in Welsh and English on screen for the teacher/parent – the presenter will also convey the meaning in BSL. As a minimum, the resource needs to include the following:
 - Fingerspelling - letters of the Welsh alphabet (1 video for each letter)
 - Fingerspelling - letters of the English alphabet (1 video for each letter)
 - Colours
 - Numbers. 3 separate videos introducing:
 - numbers from 1 – 10
 - numbers from 11 – 20
 - numbers 30, 40, 50, 60, 70, 80, 90, 100, 1000
 - General/popular signs (please; thank you; I'm sorry; that's interesting; again please; deaf; deafened);
 - Any sign that is relevant to festivals and celebrations (for example Christmas, Easter, other religious festivals, new year, birthday)
 - School signs (school, hall, class, yard, teacher, break/play time, lunch, assembly, building, role play, books, paint, glue, story/story time)
 - Greetings (hello, good morning, good afternoon, good evening, good night, you're welcome)
 - Natural resources (leaves, twigs, stones, pine cones, sand, water)
 - Simple questions and phrases
 - Feelings/emotions (how are you?, happy, excited, sad, scared, anxious)
 - Signs showing time (yesterday, now, tomorrow, the weekend, during the holidays etc.)
 - General language conceptions (large and small, up and down, more than, less than, equal)
- 2 interactive activities are required for each topic - these will be a means to test and reinforce the learners understanding. **During the development process, practitioners may wish to include further activities and content – you should therefore include separate costs for each additional activity, as well additional cost for individual videos. There is space to include these costs in the price schedule.**
- Teacher guidance should accompany the video clips. They should include ideas on how to use the resource within a classroom with individuals and/or small groups.

ii. Format - Requirements

- Each video must clearly show the sign. The presenter should demonstrate clearly the shape of the hand, as well as the facial expression. The sign should be repeated within each video clip: sign, demonstrate the hand shape, sign again.

- It should be possible to easily navigate from one clip to another, as well as being able to choose a clip from the resource menu (rather than having to go through the resource from the beginning to reach the relevant clip)
- It should be possible to use the resource on all digital devices as well as an interactive whiteboard.
- Users should be able to click on an option to see Welsh/English text on screen.

General Requirements

4. Timescale

The project should be completed and on Hwb by September 2022.
