Thank you for your request to the Welsh Government for information received on 12 August 2022. The provisions enshrined within the Freedom of Information Act 2000 provides right of access to what is held as recorded information at the time the request is made. However, the Act does not require us to share our opinion on matters. Consequently, we have concluded that the following will be dealt with under the Freedom of Information Act (2000) (FOIA):

- 1. What is the average number of days worked per week by the GP's?
- 2. What are the average hours per day worked by the GP's?
- 3. What is the average number of daily face-to-face (not telephone) appointments by the GP's?
- 4. What is the average annual salary of the GP's?
- 5. When GP surgeries are funded, do they have to commit to any minimum standards, if so, what are these standards?

With regards to the other points that you have raised in your letter, this will be dealt with as correspondence, and you will have a response in due course.

Response

- 1. What is the average number of days worked per week by the GP's?
- 2. What are the average hours per day worked by the GP's?
 - GP workforce statistics are published quarterly by Welsh Government and Stats Wales. The latest release was on 28th July and can be found at <u>General</u> <u>practice workforce: as at 31 March 2022 | GOV.WALES</u>.
 - As per the release, there are 2,324 fully qualified GPs with a Full Time Equivalent (FTE) of 1,581.0 (or 68.0% of the headcount); this includes partners, providers, salaried, retainers and active locums
- 3. What is the average number of daily face-to-face (not telephone) appointments by the GP's?
 - This data is not recorded.
- 4. What is the average annual salary of the GP's?

- NHS Digital publishes yearly the earnings and expenses information for full and part-time GPs working in the UK as either a contractor or salaried GP, and can be found at <u>GP Earnings and Expenses Estimates 2019/20 - NHS Digital</u>.
- As per the latest published data, the average GP in Wales had income before tax of £97,600.

5. When GP surgeries are funded, do they have to commit to any minimum standards, if so, what are these standards?

 GP Practices provide services and are funded through a contractual relationship with NHS Wales, managed by individual Health Boards. The contract held between the health board and practice must set out the days, hours and the service they are contracted to provide. Health boards are responsible for monitoring the services delivered under the GMS contract

Next Steps

The request you sent me contains personal information about you - for example, your name and address.
