

**GORCHYMYN CEFNFFORDD YR A483
(GARTH ROAD A FFORDD Y PARC,
LLANFAIR-YM-MUALLT, POWYS)
(GWAHARDD AROS) 202-**

Mae Gweinidogion Cymru yn bwriadu gwneud Gorchymyn drwy arfer eu pwerau o dan adrannau 1(1), 2(1), 2(2), 4(2) a 124(1)(d) o Ddeddf Rheoleiddio Traffig Ffyrdd 1984, a pharagraff 27 o Atodlen 9 a pharagraffau 2 a 5 o Atodlen 10 iddi.

Effaith y Gorchymyn arfaethedig fydd gwahardd aros ar unrhyw adeg ar ochrau'r darnau o gefnffordd yr A483 o'r enw Garth Road a Ffordd y Parc yn Llanfair-ym-Muallt, Powys a bennir yn yr Atodlen i'r Hysbysiad hwn.

Ar hyn o bryd, gwaherddir aros ar rai darnau o'r gefnffordd o dan sylw yn rhinwedd 'Gorchymyn Cefnffordd (Llanfair-ym-Muallt, Powys) (Gwahardd Aros) 1979', a gaiff ei ddirymu a'i ailosod gan y Gorchymyn arfaethedig.

Yn ystod cyfnod o 21 o ddiwrnodau o 15 Medi 2022 ymlaen, gellir edrych ar gopi o'r Gorchymyn arfaethedig, ynghyd â phlan a Datganiad o'r Rhesymau dros wneud y Gorchymyn, yn rhad ac am ddim, yn ystod oriau agor arferol yn Llyfrgell Llanfair-ym-Muallt, Antur Gwy, Ffordd y Parc, Llanfair-ym-Muallt, LD2 3BA.

Gellir hefyd gael copiau yn rhad ac am ddim drwy ysgrifennu at y cyfeiriad neu'r cyfeiriad e-bost isod gan ddyfynnu'r cyfeirnod qA1487439.

Fel rhan o'r broses ymgynghori caniateir i ni roi gwybodaeth iddynt, gan gynnwys gwybodaeth yr ydych wedi ei rhoi i ni a'ch data personol. Ni fyddwn, fodd bynnag, yn datgelu eich manylion personol ond pan fo hynny'n angenrheidiol er mwyn ymdrin â'r materion a godwyd. **THE A483 TRUNK ROAD (GARTH ROAD AND PARK ROAD, BUILTH WELLS, POWYS)
(PROHIBITION OF WAITING) ORDER
202-**

The Welsh Ministers propose to make an Order in exercise of their powers under sections 1(1), 2(1), 2(2), 4(2) and 124(1)(d) of, paragraph 27 of Schedule 9 to, and paragraphs 2 and 5 of Schedule 10 to the Road Traffic Regulation Act 1984.

The effect of the proposed Order will be to prohibit waiting at any time on sides of the lengths of the A483 trunk road known as Garth Road and Park Road at Builth Wells, Powys specified in the Schedule to this Notice.

Waiting is currently prohibited on some lengths of the trunk road concerned by virtue of the 'Trunk Road (Builth Wells, Powys) (Prohibition of Waiting) Order 1979', which will be revoked and re-imposed by the proposed Order.

During a period of 21 days from 15 September 2022, a copy of the proposed Order, together with a plan and a Statement of Reasons for making the Order, may be inspected, free of charge, during normal opening hours at Builth Wells Library, Antur Gwy, Park Road, Builth Wells LD2 3BA.

Copies may also be obtained free of charge by writing to the address or email address below quoting reference number qA1487439.

Objections, specifying the grounds on which they are made and quoting reference number qA1487439, must be sent by email to TransportOrdersBranch@gov.wales or in writing to Welsh Government, Orders Branch, Transport, Cathays Park, Cardiff CF10 3NQ by 6 October 2022.

Should you wish to object, support or make representations, the Welsh Government may need to consult with people and organisations outside of the Welsh Government. As part of the consultation process we may pass information to them, including information you have given us and your personal data. We will however, only disclose your personal details where it is necessary to do so to address the issues raised. If you do not wish for personal data to be forwarded to third parties, you should state this when submitting your correspondence and the Welsh Ministers will copy the representations to the appropriate third parties with the name and address removed and if there is to be a local Public Inquiry, the representations will be seen by the Inspector who may give them less weight as a result.

1. Y darn o ochr ogleddol y gefnffordd o'r enw Garth Road sy'n ymestyn o bwynt 84.5 o fetrau i'r gorllewin o'i chyffordd â'r ffordd fynediad sy'n arwain at yr orsaf dân hyd at bwynt 109.7 o fetrau i'r gorllewin o'r gyffordd honno.

2. Y darn o ochr ddeheuol y gefnffordd o'r enw Garth Road sy'n ymestyn o linell cwrn orllewinol ei chyffordd â Hospital Road hyd at bwynt 58.2 o fetrau i'r gogledd-orllewin o'r gyffordd honno.

3. Y darn o ochr ogleddol y gefnffordd o'r enw Ffordd y Parc sy'n ymestyn o linell cwrn orllewinol ei chyffordd â'r ffordd a elwir hefyd yn Ffordd y Parc hyd at bwynt 24.1 o fetrau i'r gorllewin o'r gyffordd honno.

4. Y darn o ochr ogleddol y gefnffordd o'r enw Ffordd y Parc sy'n ymestyn o linell cwrn ddwyreiniol ei chyffordd â'r ffordd a elwir hefyd yn Ffordd y Parc hyd at bwynt 25.4 o fetrau i'r dwyrain o'r gyffordd honno.

5. Y darn o ochr ogleddol y gefnffordd o'r enw Ffordd y Parc sy'n ymestyn o bwynt 21 o fetrau i'r gorllewin o'i chyffordd â ffordd fynediad yr U0852 hyd at bwynt 71 o fetrau i'r gorllewin o'r gyffordd honno.

6. Y darn o ochr ogleddol y gefnffordd o'r enw Ffordd y Parc sy'n ymestyn o linell cwrn orllewinol ei chyffordd â'r ffordd fynediad sy'n arwain at Ysgol Calon Cymru hyd at bwynt 22.5 o fetrau i'r gorllewin o'r gyffordd honno.

SCHEDULE

Prohibition of waiting

1. The length of the northern side of the trunk road known as Garth Road that extends from a point 84.5 metres west of its junction with the access road leading to the fire station to a point 109.7 metres west of that said junction.

2. The length of the southern side of the trunk road known as Garth Road that extends from the western kerbline of its junction with Hospital Road to a point 58.2 metres north west of that said junction.

3. The length of the northern side of the trunk road known as Park Road that extends from the western kerbline of its junction with the road also known as Park Road to a point 24.1 metres west of that said junction.

4. The length of the northern side of the trunk road known as Park Road that extends from the eastern kerbline of its junction to the road also known as Park Road to a point 25.4 metres east of that said junction.

5. The length of the northern side of the trunk road known as Park Road that extends from a point 21 metres west of its junction with the U0852 access road to a point 71 metres west of that said junction.

6. The length of the northern side of the trunk road known as Park Road that extends from the western kerbline of its junction with the access road leading to Ysgol Calon Cymru to a point 22.5 metres west of that said junction.
