Agenda is attached.

Discussion topics included development opportunities, exam invigilator training, exam registration, Welsh language, and the parent support handbook.

There were 44 attendees in total: 20 Local Authority officers, 3 Welsh Government officials, 1 representative from the office of the Children's Commissioner; and 20 parents.

Cardiff City Stadium 11th October 2019, Llandudno 18th October 2019 and Swansea 21st October 2019

Discussion topics included legal responsibilities and rights, identifying children not known to local authorities, the requirement to demonstrate an efficient and suitable education

We do not hold the breakdown of attendees per event. There were a total of 72 attendees across all 3 events. This included 9 children. We are unable to provide this breakdown per event, as this may lead to identification.

The events referred to in Q2 were not rescheduled, however the online consultation remained open until 22nd April 2020.
