Thank you for your request for information dated 12 September.

Your Request

You have asked for the following information regarding the A465 widening scheme:

1. Could you please provide a detailed list of the public funds which have been paid and to which organisation

Could you please return your response in an excel document in 2 columns Column A - Organisation Name Column B - Amount paid/compensated

Our response

As your request currently stands, I believe it will be very time consuming to deal with. Requesting a broad scope of information (the detailed list of public funds paid to organisations following the A465 scheme) as described over a long timeframe makes the search very difficult and time consuming. We hold data for all 6 sections of the A465, however the older sections will take more time to locate as some of the records date back to 2004-2005 which pre-dates our current filing system.

The information requested is stored on our electronic filing system where we store our financial spreadsheets for each road scheme. This consists of 6 spreadsheets for the A465, one for each section, including more than 1,000 claims across the 6 sections of the A465. Setting our systems in this way, and in line with our Records Management policy, enables effective delivery and will not necessarily lend themselves to being easily interrogated for generic requests for information.

A general search using the search terms 'A465 scheme compensation' yielded almost 24,743 results. At an average estimate of one minute per result to check whether it is relevant to your request and then extracting the relevant information, it would take one official at in excess of four working days. Some information will also be held on paper files and would take a substantial amount of time to locate, retrieve and extract the data you have requested.

If I estimate it will take more than 24 working hours of time to determine whether we hold the information and to thereafter locate, retrieve and extract it, the Freedom of Information and Data Protection (Appropriate Limit and Fees) Regulations 2004 allow

me to refuse to deal with it. The appropriate limit specified for central government is £600, representative of the estimated cost if taking over 24 working hours of time.

You may wish to refine your request by narrowing its scope, however, it is important to note that most of the information you have requested contains personal data and will likely be exempt from publication under Section 40 of the Freedom of Information Act, personal information. If you do refine your request, this will be treated as a new request.

Next steps

If you are dissatisfied with the Welsh Government's handling of your request, you can ask for an internal review within 40 working days of the date of this response. Requests for an internal review should be addressed to the Welsh Government's Freedom of Information Officer at:

However, please note that the Commissioner will not normally investigate a complaint until it has been through our own internal review process.

The request you sent me contains personal information about you - for example, your name. We will only use this personal information to deal with your request and any matters which arise as a result of it.
