Annex A

1. The UK Government is responsible for energy security across Great Britain. The context you provided with your request for information discusses the possibility of restrictions in gas supplies into the GB energy market. You may be interested in the Gas Winter Outlook published by National Grid (Gas Winter Outlook, Review and Consultation | National Grid Gas. In the event of a risk event to GB gas supplies, the UK Government, as lead responsibility for energy security, would follow the National Emergency Plan for gas and electricity. The actions are set out in the following document (National Emergency Plan for downstream gas and electricity - GOV.UK (www.gov.uk). There is no separate Wales plan, Wales is incorporated into the UK Government plan.

The Welsh Government has arrangements for dealing with emergencies and communicating appropriately with local responders and other UK Administrations. In relation to most types of emergency situations, and in adherence to the duties set out in Civil Contingencies Act 2004, local agencies such as Police, Health Fire and Rescue Services and Local Authorities are responsible for the identification of risks in their area, developing and maintaining plans to mitigate and respond to an emergency, raising awareness and communicating with those who may be affected and co-operating with other local agencies. To complete this effectively, the agencies come together to form a Local Resilience Forum (LRF). We have four LRF in Wales, whose areas mirror the Police authority areas: South Wales, Dyfed Powys, North Wales and Gwent. The LRF is primarily responsible for the preplanning phase. In the event of an emergency, the LRF members reform and the local multiagency response phase is co-ordinated through a Strategic Co-ordinating Group (SCG) located in the Strategic Co-ordination Centre (SCC). If an emergency situation were to occur, it would also require the Welsh Government to stand up the Emergency Co-ordination Centre (Wales) ECC(W).

There is no specific Wales gas reserve. Energy Security is a reserved matter and the
responsibility of the UK Government. Managing the Gas network is the responsibility
of National Grid. Information on gas reserves was recently published in the Gas
Winter Outlook from National grid (Gas Winter Outlook, Review and Consultation |
National Grid Gas).
