Enwi a Chychwyn

1. Enw'r Gorchymyn hwn yw Gorchymyn Cau Priffyrdd (Milton Court a Ringland Centre, Casnewydd) 2022 a daw i rym ar 2 Tachwedd 2022.

Dehongli

2. Yn y Gorchymyn hwn—

ystyr “y Cyngor” (“*the Council*”) yw Cyngor Dinas Casnewydd;

ystyr “y datblygwr” (“*the developer*”) yw'r person sy'n gwneud y datblygiad y mae'r caniatâd cynllunio wedi ei roi ar ei gyfer;

ystyr “Deddf 1990” (“*the 1990 Act*”) yw Deddf Cynllunio Gwlad a Thref 1990; ac

ystyr “y planiau a adnewwyd” (“*the deposited plans*”) yw'r planiau sy'n dwyn yr enw “Gorchymyn Cau Priffyrdd (Milton Court a Ringland Centre, Casnewydd) 2022” ac a farciwyd Cam 1 a Cham 2 o dan y cyfeirnod qA1551887 sy'n dod gyda'r Gorchymyn hwn.

Cau Priffyrdd

3. Yn ddarostyngedig i erthyglau 4, 5, 6 a 7 o'r Gorchymyn hwn mae Gweinidogion Cymru yn awdurdodi cau'r darnau o briffordd a ddisgrifir yn Atodlen 1 i'r Gorchymyn hwn ac a ddangosir â llinellau sebra ar y planiau a adnewwyd. Mae Gweinidogion Cymru wedi eu bodloni bod angen cau'r priffyrdd er mwyn gwneud y datblygiad yn unol â'r caniatâd cynllunio amlinellol a roddwyd o

TOWN AND COUNTRY PLANNING ACT 1990

THE STOPPING UP OF HIGHWAYS (MILTON COURT AND RINGLAND CENTRE, NEWPORT) ORDER 2022

Made 26 October 2022
Coming into force 2 November 2022

The Welsh Ministers, in exercise of their powers under section 247 of the Town and Country Planning Act 1990(1), make this Order.

Title and Commencement

1. The title of this Order is the Stopping Up of Highways (Milton Court and Ringland Centre, Newport) Order 2022 and it comes into force on 2 November 2022.

Interpretation

2. In this Order—

“the Council” (“*y Cyngor*”) means Newport City Council;

“the deposited plans” (“*y planiau a adnewwyd*”) means the plans entitled “The Stopping Up of Highways (Milton Court and Ringland Centre, Newport) Order 2022” and marked Phase 1 and 2 with reference qA1551887 which accompany this Order;

“the developer” (“*y datblygwr*”) means the person carrying out the development for which the planning permission has been granted; and

“the 1990 Act” (“*Deddf 1990*”) means the Town and Country Planning Act 1990.

Stopping Up

3. Subject to articles 4, 5, 6 and 7 of this Order the Welsh Ministers authorise the stopping up of the lengths of highway described in Schedule 1 to this Order and shown by zebra hatching on the deposited plans. The Welsh Ministers are satisfied that the stopping up is necessary to enable development to be carried out in accordance with outline planning permission granted under Part 3 of the 1990 Act by the

dan Ran 3 o Ddeddf 1990 gan y Cyngor ar 3 Hydref 2019 o dan y cyfeirnod 18/1181 a'r gymeradwyaeth ar gyfer materion a gadwyd yn ôl a roddwyd ar 19 Ionawr 2022 o dan y cyfeirnod 19/1272 a ddisgrifir yn Atodlen 3 i'r Gorchymyn hwn.

Priffordd Newydd

4. Rhaid creu, er boddhad rhesymol y Cyngor, y darn newydd o briffordd a ddisgrifir yn Atodlen 2 i'r Gorchymyn hwn ac a ddangosir â dotwaith ar y plan a adnewyd, sydd, at ddibenion Deddf Priffyrdd 1980(1), i fod yn briffordd i'w chynnal ar draul y pwrs cyhoeddus. Y Cyngor fydd yr awdurdod priffyrdd sy'n gyfrifol amdani.

Y Priffyrdd y Gwneir Gwelliannau Iddynt

5. Rhaid gwneud gwelliannau, er boddhad rhesymol y Cyngor, i'r darnau o briffordd a ddisgrifir yn Atodlen 3 i'r Gorchymyn hwn, sydd, at ddibenion Deddf Priffyrdd 1980, yn briffyrdd i'w cynnal ar draul y pwrs cyhoeddus. Y Cyngor fydd yr awdurdod priffyrdd sy'n gyfrifol amdanynt.

Y Darpariaethau sy'n Angenrheidiol neu'n Hwylus cyn Cau Priffyrdd

6. Ni chaniateir cau'r darnau o briffordd a ddisgrifir yn Atodlen 1 i'r Gorchymyn hwn—

- (a) hyd nes y bydd y datblygwr wedi darparu, er boddhad rhesymol y Cyngor, blaniau sy'n dangos sut y mae'r darnau o briffordd i'w cau;
- (b) hyd nes y bydd y datblygwr wedi darparu'r darn newydd o briffordd a ddisgrifir yn Atodlen 2 i'r Gorchymyn hwn er boddhad rhesymol y Cyngor;
- (c) hyd nes y bydd y datblygwr wedi gwella'r darnau o briffordd a ddisgrifir yn Atodlen 3 i'r Gorchymyn hwn er boddhad rhesymol y Cyngor;
- (d) hyd nes y bydd y datblygiad a ddisgrifir yn Atodlen 4 i'r Gorchymyn hwn wedi ei ddechrau a bod y datblygwr wedi hysbysu'r Cyngor yn ysgrifenedig ei bod yn angenrheidiol cau'r darnau o briffordd er mwyn i'r datblygiad fynd rhagddo; a
- (e) hyd nes y bydd y Cyngor wedi ysgrifennu at y datblygwr i gadarnhau bod paragraffau (a), (b), (c) a (d) wedi eu bodloni.

Ymgymerywyr Statudol a Darparwyr

7. Pan fo gan ymgymerywyr statudol neu ddarparwyr system gyfathrebu gyhoeddus unrhyw gyfarpar o dan y briffordd, ynddi, arni, drosti, ar ei

New Highway

4. There will be created, to the reasonable satisfaction of the Council, the new length of highway described in Schedule 2 to this Order and shown by stipple marking on the deposited plan, which is to be highway maintainable at the public expense for the purposes of the Highways Act 1980(1) and the Council is to be the highway authority responsible for it.

Improved Highways

5. There must be improvements made, to the reasonable satisfaction of the Council, to the lengths of highway described in Schedule 3 to this Order, which is highway maintainable at the public expense for the purposes of the Highways Act 1980 and the Council is to be the highway authority responsible for them.

Provisions Necessary or Expedient before Stopping Up

6. The lengths of highway described in Schedule 1 to this Order must not be stopped up until—

- (a) the developer has provided, to the reasonable satisfaction of the Council, plans showing how the lengths of highway are to be stopped up;
- (b) the developer has provided the new length of highway described in Schedule 2 to this Order to the reasonable satisfaction of the Council;
- (c) the developer has improved the lengths of highway described in Schedule 3 to this Order to the reasonable satisfaction of the Council;
- (d) the development described in Schedule 4 to this Order has commenced and the developer has informed the Council in writing of the necessity to stop up the lengths of highway to allow the development to proceed; and
- (e) the Council has confirmed in writing to the developer that paragraphs (a), (b), (c) and (d) are satisfied.

Statutory Undertakers and Providers

7. Where immediately before the length of highway is stopped up, there is under, in, on, over, along or across the highway any apparatus of statutory undertakers or public communications providers then

2. Hyd a lled cyfan y briffordd o'r enw Ringland Centre, yng Nghasnewydd, yn mynd i gyfeiriad y gogledd-orllewin o'i chyffordd â Cot Farm Close, sydd â chyfanswm arwynebedd o 2563 o fetrau sgwâr, ac sydd wedi ei labelu â 'D' ac wedi ei marcio â llinellau sebra ar y plan a adnewyd ar gyfer Cam 2.

(All measurements are approximate)
Lengths of highway to be stopped up

1. The highway known as Milton Court, in Newport, located to the south of the Hendre Farm Court / Ringland Circle roundabout, heading in a south-westerly direction from its junction with Hendre Farm Court to its junction with Ringland Circle, with a maximum surface of 1256.4 square metres, labelled 'C' and marked with zebra hatching on the deposited plan for Phase 1.
2. The full extent of the highway known as Ringland Centre, in Newport, heading in a north-westerly direction from its junction with Cot Farm Close, with a maximum surface of 2563 square metres, labelled 'D' and marked with zebra hatching on the deposited plan for Phase 2.

Length of new highway to be provided

An irregular shaped length of highway connecting from a point to the south of Ringland roundabout to a point on the junction of Milton Court and Ringland Circle, heading in a south-westerly direction, with a maximum surface of 178 square meters, labelled 'A' and marked with stipple hatching in the deposited plan for Phase 1.

1. Darn afreolaidd ei siâp o briffordd ar y briffordd o'r enw Milton Court, Casnewydd, o bwynt ar ei chyffordd â Ringland Circle, yn mynd i gyfeiriad y de-ddwyrain, sydd â chyfanswm arwynebedd o 167 o fetrau sgwâr, ac a ddangosir â chroeslinellau ac y rhoddir y cyfeirnod 'B' iddi ar y plan a adnewwyd ar gyfer Cam 1.
2. Darn afreolaidd ei siâp o briffordd ar ymyl gorllewinol Ringland Centre, Casnewydd, o bwynt ar ei chyffordd â Cot Farm Circle yn mynd i gyfeiriad y gogledd-orllewin, sydd â chyfanswm arwynebedd o 66 o fetrau sgwâr, ac sydd wedi ei labelu ag 'E' ac wedi ei marcio â chroeslinellau ar y plan a adnewwyd ar gyfer Cam 2.

ATODLEN 4
Y Datblygiad

Dymchwel Ringland Centre, 6 byngalo a llyfrgell ac adeiladu tua 170 o gartrefi a 1700 o fetrau sgwâr o arwynebedd llawr a1/a2/a3, yn ogystal â gwaith tirlunio, rhwydwaith ffyrdd mewnol, cyfleusterau parcio a seilwaith cysylltiedig.

Caiff y datblygiad ei wneud mewn dau gam, a'i gyflawni ar adegau gwahanol. Gwneir gwaith ar yr ardal siopa ogleddol yn gynharach yn y rhaglen waith.

SCHEDULE 3
(All measurements are approximate)
Lengths of highway to be improved

1. An irregular shaped length of highway on the highway known as Milton Court, Newport, from a point on its junction with Ringland Circle, heading in a south-eastern direction, with a maximum surface of 167 square meters, shown by cross hatching and given the reference 'B' on the deposited plan for Phase 1.
2. An irregular shaped length of highway located on the west edge of Ringland Centre, Newport, from a point on its junction with Cot Farm Circle heading in a north-west direction, with a maximum surface of 66 square metres, labelled 'E' and marked with cross hatching in the deposited plan for Phase 2.

SCHEDULE 4
The Development

Demolition of Ringland Centre, 6no. bungalows and library and construction of approximately 170no. homes and 1700 square metres of a1/a2/a3 floorspace, landscaping, internal road network, car parking and associated infrastructure.

The development will fall into two phases and will be executed at different times, with the northern shopping area featuring earlier in the program.
