Please provide the details of the act of parliament where the Welsh Government has changed the speed limits on the M4 around Newport Gwent.

Our response

I can confirm the Welsh Government holds information captured by your request.

The regulation used for the M4 50mph Speed Limit around Newport is the Road Traffic Regulation Act 1984.
