## ATISN 16914 - Save a Life Cymru AED's

Thank you for your request to the Welsh Government for information under the Freedom of Information Act (2000) received on 29 November 2022. You have requested the following:

- 1. Can you please confirm how much funding has been given to Save a Life Cymru (SaLC) with regards to public access defibrillators (AEDs)?
- 2. How many were purchased?
- 3. Of those purchased how many have now been allocated and now publicly available in Welsh Communities?

## **Our Response**

Some of the information you have requested can be found in the public domain and for your convenience, I have provided links to where you can locate the information you are seeking.

Statements were issued on 15 October 2021 and 25 February 2022 allocating a total of £1 million to Save a Life Cymru for the purchase of defibrillators for which community groups and organisations could apply. Copies of these statements can be found <a href="here">here</a> and <a href="here">here</a>.

On 14 October 2022, Welsh Government provided an update to the scheme which can be found here

New funding to increase defibrillator access in Wales | GOV.WALES 'We are committed to improving community access to defibrillators to boost cardiac arrest survival rates,' vows Health Minister | GOV.WALES

In total, 1,000 defibrillators were purchased with the £1 million funding provided.

- 672 defibrillator requests from community groups have been approved. 250
  defibrillators have been distributed so far. The remaining applicants are in the
  process of preparing for the installation of the defibrillators (for example, by securing
  the storage cabinet and identifying the guardian required) and they are all being
  contacted by Save a Life Cymru to ascertain progress so the equipment can be
  released to them when they are ready.
- 250 have been allocated to larger community projects working in partnership with the Football Association of Wales, Welsh Ambulance Service NHS Trust and South Wales Fire and Rescue.

 A number of applications are currently being reviewed in relation to the allocation of the remaining 78 defibrillators, and any not allocated via this process will be used to support larger projects.

## **Next steps**
