## **ATISN 16934**

Please find below a response to WQ86889. You asked for recorded information, so it has been handled as a Freedom of Information request on ATISN 16934.

Your request asked: How much of the £165 million capital investment allocated to the tourism, sports and arts industries announced by the Welsh Government in the 2022-23 budget has been allocated, and to which projects? (WQ86889)

Response: the £165m relates to the three-year budget, which was published in 2022. The capital allocations are as below.

Information on individual projects is not held where it relates to Arm's Length Bodies' allocations. However, funding allocated directly by Welsh Government is held:

### Cadw

The budget for Cadw's capital grants to external bodies for 2022-23 is £1.4 million. This funds grants for conservation of historic assets including historic buildings and scheduled monuments. Grant schemes support maintenance and conservation projects and prioritise action to tackle historic assets at risk and buildings providing community benefits.

Cadw is delivering capital conservation and investment projects to the value of £8.233 million in 2022-23. Of the 130 monuments in the guardianship of Welsh Government, over 15 are receiving direct investment including, Caernarfon, Caerphilly and Coity Castle, Neath Abbey and Tretower Court.

# **Creative Wales**

The budget for Creative Wales's capital grants for 2022-23 is £5 million. This has been granted as follows:

Production funding - £3,734,931 Studio Development - £376,250 Priority sector Support £886,112

Total Capital Allocated - £4,997,293

## Tourism

The Tourism Development annual budget of £5m is allocated to our Brilliant Basics Scheme and the Strategic Capital Investment Fund.
