ATISN 16933 Funding for bus services

Information requested

Thank you for your request which I received on 5 December 2022. You asked for details of how much each of the 22 local authorities in Wales received in funding to delivery bus services in the financial years:

2018-19; 2019-20; 2020-21; 2021-22; and 2022-23.

Our response

Local authorities receive a settlement each year to fund their services. This is unhypothecated and as such it is for local authorities and their elected councils to determine how they fund each of their service areas. The settlement is determined using a formula to calculate the relative split of funding between the 22 authorities in Wales, which also takes into account their ability to raise funding from council tax. Background information on this can be found in the Green Book, the last published was for 2020-21 Local government revenue and capital settlement: background information for standard spending assessments (Green book) 2020 to 2021 GOV.WALES.

Other than the main settlement funding for local authority's determined each year, there are individual grants awarded for specified purposes (see the data presented in the table at the end of this letter. However, please be aware that one grant (Bus Services Support Grant (BSSG)) given by the Welsh Government is paid to three lead authorities representing north Wales (Flintshire), south east Wales (Monmouthshire) and south west Wales (Swansea): who would then share out that funding across their local authorities according to their local agreement. Powys and Ceredigion receive individual BSSG awards. This funding mechanism was duplicated for the bus support funding provided by Welsh Government in response to the impact of the COVID pandemic on the bus network and operators fare income.

Next steps

If you are dissatisfied with the Welsh Government's handling of your request, you can ask for an internal review within 40 working days of the date of this response.
