You have asked for the following information on EV charging points in Wales:

- 1. The number of EV charging points per year since 2019

## Our response

I can confirm that we hold information captured by your request. For question one, the latest EV charging infrastructure statistics are publicly available on the Department for Transport website. The following link presents statistics on the number of publicly available electric vehicle charging devices in the UK, broken down by Local Authority for July to September 2022. <u>Electric vehicle charging device statistics</u>: October 2022 - GOV.UK (www.gov.uk)

The table below contains data on the number of publicly available Electric Vehicle Charging Devices in Wales per year since 2019. These include 'Rapid charging or above devices' that is to say those whose fastest connector is rated at 25kW or above. A device can have a number of connectors of varying speeds:
