## **ATISN 17028 – Covid Dashboard**

Thank you for your request to the Welsh Government for information under the Freedom of Information Act (2000) received on 09 January 2023. You have requested the following:

*To provide an updated version of the dashboard provided in Sep 2022 for the Welsh Government Covid Nosocomial Investigations including:*

- *split by health board and NHS run care homes from March 2020 to Dec 2022*
- *split by investigations into deaths vs infections*
  1. *Completed investigations*
  2. *Downgraded*
  3. *Recategorised*
  4. *Referred to Scrutiny panel*
  5. *In progress*
  6. *Not started*
- *To confirm the frequency that each HB and care home provide the Welsh Gov with this information and the last reporting period?*

## **Our Response**

The most recent dashboard data held by the Welsh Government which covers the period up to November 2022 is attached below. The table includes the total number of cases to be investigated, investigations not started, investigations in progress and the number of investigations completed up to the end of November 2022.

The Welsh Government does not hold data on downgraded or recategorised cases, or cases referred to scrutiny panel, or cases in NHS funded care homes. The Welsh Government does not hold data split by investigations into deaths versus infections.

The NHS Delivery Unit updates the Welsh Government monthly. The data below is the most up to date information currently held by the Welsh Government. The next update is due at the end of January 2023 which will include data up to the end of December 2022.
