Thank you for your request to the Welsh Government for information under the Freedom of Information Act (2000) received on 18 January 2023. You have requested the following:

1. How many anterior hip replacement procedures have been undertaken in Wales since 2019 to date in total and can this be broken down by the Trust?

2. Have any Welsh patients had an anterior hip replacement procedure undertaken in an English hospital under a Wales NHS referral since 2018, if so please can you provide the English and Welsh Trust details

Response
