## **Annex 1**

### **Application of exemptions/exceptions**

The Freedom of information Act/Environmental Information Regulations provide a right for anyone to ask a public authority to make requested information available to the wider public. As the release of requested information is to the world, not just the requester, public authorities need to consider the effects of making the information freely available to everybody. Any personal interest the requester has for accessing the information cannot override those wider considerations.

I have decided to withhold the following information:

The direct email addresses, phone numbers and fax numbers of third parties.

This Annex sets out the reasons for the engagement of section *S40 Personal information* of the Freedom of Information Act of the Environmental Information Regulations and our subsequent consideration of the Public Interest Test.

The Welsh Government believes that the personal information of third should be exempt from disclosure.

### **Public Interest Test**

In order to satisfy the public interest test in relation to the exemption, it is necessary to conclude that the public interest arguments in favour of withholding the information are sufficient to *outweigh* the public interest arguments in favour of release.

### **Public interest arguments in favour of disclosure**

Full disclosure of all information. Avoiding the appearance of withholding information.

### **Public interest arguments in favour of withholding**

The third party individuals involved have not been asked to nor have given their consent to release their personal contact information.

The withheld information is not key to the records and does not affect the understanding or completeness of the records being released.

### **Balance of public interest test**

On balance, the public interest of releasing the information does not outweigh the need to protect third party personal information. I have decided to release the correspondence requested and to withhold the personal information of the third parties.
