## Responses:

1. How many written responses did you have for the Anti Racism Wales Action Plan?

330 responses were received as set out in the published summary of responses: Race Equality Action Plan: An Anti-racist Wales | GOV.WALES

2. How many did you have in English, and how many did you have in Welsh?

Two written responses were in Welsh only. The remaining responses were in English.

3. What proportion of key performance indicators were achieved by March 2022? What KPIs were these?

We hold no such recorded information. The Anti Racist Wales Action Plan was published on 7 June 2022. We do not hold information about KPIs achieved by March 2022.

The Anti-Racist Wales Action Plan includes detailed actions across a range of policy topics. Each action is supported by a description of key outputs and outcomes. It also states when the action is expected to be completed and the organisation or organisations responsible for delivery. These organisations are referred to in the column headed 'leads or partners'.

Organisations referred to as 'leads or partners' have not been awarded a particular status. It reflects their organisational remit as having responsibility for implementing the actions. They are primarily public sector bodies, based in Wales.
