## Information requested

Thank you for your request which I received on 26 January 2023. You asked for:

Following your response to my clarification letter I sent on 30 January, you emailed an amended request that narrowed the scope to include all recorded dates and minutes of meetings between Dawn Bowden and/or her officials and the WRU relating to Amanda Blanc, any ongoing investigation into allegations of sexism, misogyny, racism, bullying or any other form of discrimination between 13 May 2021 and 25 January 2023. Alongside this, you also requested any correspondence relating to the 2021 report into the women's game and to transgender issues.

## Our response

Regarding your request for all written correspondence between Dawn Bowden and/or her officials and Amanda Blanc between 13 May 2021 and 25 January 2023 inclusive; following a search of our paper and electronic records, I have established that there is no information pertinent to this request held by the Welsh Government.

Likewise, your request for all written correspondence between Dawn Bowden and/or her officials and Ieuan Evans, Chairman of the WRU, between 29 November 2022 and 25 January 2023 also returned no information.



#### Dear Steffan

Thank you for your reply below and your time on the phone on Tuesday.

The criteria for any future SSF are clear, as I hope are the figures we shared with you that we discussed on Tuesday.

The fluidity of the current situation makes any form of certainty difficult. I know the many challenges we face and I am mindful that these are multiplied exponentially at a governmental level. However, we are very much at the point where we need to make certain commitments in the next few days that will be sunk costs. Staffing, as was highlighted in the recent Autumn, remains a huge challenge across the sector and we will need to contract with thousands of temporary staff members in order to secure them should restrictions change enabling us to have crowds.

From conversations with other Six Nations participants, it is clear they had notice of the lifting of restrictions. My ask is that we are afforded as much notice as possible of any change that will affect on our ability to have a crowd. We can effectively press 'go' on the 21 January but it will be a scramble but I am confident we can deliver. However, any notice ahead of the next scheduled update would be priceless in terms of our ability to deliver these events safely. For clarity, should there be a change in restrictions announced after the 21<sup>st</sup> it would be highly unlikely that we would be in a position to properly stage the Scotland game with fans in attendance.

It is also important to consider that ample notice is vital for other organisations that will need to respond to the event going ahead with supporters, not least the transport infrastructure, police, ambulance etc., along with hospitality businesses and hotels within South Wales.

I appreciate that it may well not be possible to commit to a specified notice period, but I hope you can commit to sharing any plans as soon as possible. I hope it goes without saying that our discretion can be taken as read.

#### **Dear Steve**

The First Minister said on Friday that in line with the modelling we do not expect the position to improve for the next 10 days to two weeks. In that context, restrictions are unlikely to change until we see the peak of the wave passing and coming down, and that will be the time at which we will look to lift some of those protections, when it is safe to do so. The position is being reviewed weekly but the next formal 21-day review is on 20 January. I suspect there will be more clarity on the position moving into February at that stage.

We have already announced SSF is there to support our decisions around restrictions and I have also highlighted our very generous support to the WRU to date – grants and ongoing loan discussions – throughout the pandemic. The SSF will continue to be in place as long as the restrictions remain.

I cannot give any guarantees around SSF in advance, in the same way we are treating all other sporting organisations and events. The fund is there to provide support, not to underwrite all losses, but I have outlined the eligibility criteria below for you to be aware of what can be supported.

I'm afraid I cannot provide any firmer commitments and you will need to take your own decisions within those parameters.

## **Eligibility for SSF**

We have worked with Sport Wales in agreeing these eligible elements and this is the consistent approach being taken forward with all sports and events impacted by the decision to restrict spectators at sporting events from 26 December. There is no commitment that these costs will be met at 100% as that is subject to an assessment of the proposals put forward and further advice to Ministers.

- Advance ticket sales income;
- Match day ticket sales income (estimated based on average match-day sales pre-Covid).
- Perishable food and beverages costs (cost price) sales receipts will be required as evidence of expenditure. Refunded costs will not be eligible and 100% of eligible costs will only be guaranteed if applicants can provide evidence perishable food was re-distributed to those in need e.g. to food banks; and

Staff costs for re-distributing perishable foods.

#### **Dear Steffan**

Thank you for your email.

We acknowledge your concerns regards Omicron cases in Wales in recent weeks. It is a matter for you to set out the required restrictions to combat such concerns and, as we've always done in the past (and as highlighted by the FM as recently as this morning), we will seek to support you as best as we are able.

We understand your concerns about moving our match against Scotland to England but we are equally coming under pressure from fans and players to pursue such a course of action; Six Nations matches are great occasions and fans want to be there and the players want the fans there; it's what makes the occasion the world renowned spectacle it is.

Whilst our intention is always to support you (as we've always done), as CEO, I cannot risk a c.£7m decision in respect of the Scotland match without certain assurances from you; that would be negligent on my part given the catastrophic consequences that would have on Welsh rugby.

Having reflected more on the matter and influenced by the timing of the Scotland match, I wonder if we should merely focus on the Scotland match for now and address the matches against France and Italy at a later date given that there's around a month between the Scotlish and French matches.

Absent an early decision, the closer we get to the match, the more disruptive it gets and mitigation becomes more difficult. This would include fan confidence in purchasing tickets, we have to commit to certain costs to stage the match but it goes much wider than that; we have suppliers seeking clarity from us and we'll have the wider Cardiff community committing to costs in the expectation that some 74,000 people will attend the match. I'm also conscious that (a) fans (both home and away) may have committed to hotels and the longer we give them, the better chance they have of mitigating those costs and (b) the wider hospitality sector in Cardiff relies on our games for business and the more notice they have the better.

We have already shared with you our financial expectations for the match against Scotland; clearly, the more notice we have the better the communication and our ability to mitigate costs. By way of example only, lifting any restrictions on, say, 1 February will be nearly as damaging given our inability to turn things around in such a short time frame.

Given the bigger picture here, I'm minded to propose a joint WG/WRU approach that supports a position that we announce that there will be no crowds at the Scotland match, it will be played in Principality Stadium but that would be on the understanding of your support for the losses that we have already shared with you. If that requires Ministerial support from you then we can work with that, we'll not make any announcements until that is resolved and we'll not commit, either way, to hosting in Twickenham; realistically, that needs to be resolved early next week. We'll get endless criticism for this from fans and players but we are prepared to deal with that given the bigger picture.

For the avoidance of doubt, our preferred approach is to have no restrictions, for us to have crowds, our commercials will look after themselves and we would not need to bother you with this issue. From a rugby performance perspective this is also clearly preferable. However, we do recognise that it is you that must govern the Omicron concerns in Wales.

There's another matter to consider here also; we are due to play England in Twickenham on 26 February and, pursuant to Six Nations protocols, the RFU are obliged to provide some 6,000 tickets to the WRU for use by Welsh fans. Most of these have already been sold and I would be keen to understand your position on that?

Please do let me know if this is something that we should jointly pursue; in addition, I would welcome any comments or questions on the financial data and the draft press release we have shared with you.

## **Annwyl Steve**

Thank you for your email and for keeping in touch with me on this matter over recent days.

There are significant concerns with regards the Omicron cases we have seen in Wales over recent weeks, hence our response after Christmas to move to alert level two in our Coronavirus control plan. The situation is evolving at pace and is being reviewed on a regular basis. Current restrictions can only be eased when the public health situation improves and it is safe for us to do so.

I can understand why the WRU would wish to explore a range of options around the Six Nations. However, it would be both disappointing and extremely reckless moving matches to England to bypass the regulations we have put in place to keep Wales safe, and encouraging thousands of Welsh rugby supporters to do the same. On that basis, I am pleased that you are only considering playing the match at the Principality Stadium.

Should Coronavirus restrictions continue to be in place for the Scotland match on 12 February, or indeed for any other of the Six Nations 2022 home matches, then it would also be the case that the Spectator Sports Fund would be available to provide support. This subject, of course, to a detailed application and final agreement by Ministers.

I agree providing clarity around the Scotland match at the earliest opportunity is advised.

**Dear Steffan** 

Thank you for your time yesterday in respect of the above.

Our only realistic English venue at which we could play our 'home' 2022 Guinness Six Nations matches would be Twickenham and, as I explained, I have had a very brief high-level discussion with the RFU CEO regarding the same. If we were to explore that further, we would realistically need to announce that in the next few days given the endless logistical challenges that would create ranging from informing our fans, reticketing the match, hospitality fulfilment, team logistics and broadcaster notifications, etc.

However, based on our very pragmatic discussion, we are content to let the Twickenham option lapse and commit to hosting this match in Principality Stadium on the understanding that "we are made whole" if the current crowd restrictions remain in place on 12 February 2022 and beyond. You have already announced a £3m Spectator

Sports Fund and our understanding is that this will not cover the time period of the Six Nations and therefore a new fund or an increased fund would be announced. The impact of lost revenues from a spectator free Six Nations would be catastrophic for the whole of the game in Wales and the communities our c.300 clubs serve.

Our losses (which would include the loss of revenue generating opportunities) arising from playing without crowds would include:

- Ticketing revenue
- Debenture obligations
- One-off hospitality revenue
- Loss of a match in the context of contractual obligations to hospitality box licence holders
- Food and beverage sales
- Merchandising sales (including at our shop on Westgate Street)
- Non-delivery of certain commercial contractual obligations

As discussed, I'll ask Tim to give us some ranges of the losses we might face and will share this with you as soon as possible. We also need to be mindful of the impact on ticket sales given the current uncertainty around restrictions; we have sold c.65,000 tickets for the Scotland match but the number of tickets sold since the recent restrictions were announced has been negligible (as has been the case for our other home matches). We accurately forecast ticket sales using historic sales data and have consequently budgeted based on these projections. Naturally, we can share this data with you. We are also seeing positive discussions with potential commercial partners dissipating given the current lack of certainty and there is a significant risk that our fans and participants will start to lose interest in rugby if the current situation continues.

In the comfort of your assurance of financial support and, also as discussed, we should consider stating publicly this week that we will play Scotland at Principality Stadium regardless of the status of restrictions; I suggest we draft something and then share with you.

## Two final points:

- we believe the fact that some 275,000 people attended games in the Autumn
  without a noticeable rise in infections should be of comfort to us all. We are well
  aware of our wider responsibilities to the health of the nation but remain hopeful
  that this will be factored in to your thinking about the return of supporters to
  stadia in the coming weeks; and
- we all need to be cognisant of the wider impact on continued restrictions to the game; this would range from fan and commercial partner confidence to participation levels in the community game given the disruption to the season. We can pick this up at a later date.

Hope that helps and aligns with your understanding and I am grateful for the continued support of Welsh Government.

## **Key points to consider:**

## 1 Why change the age of mixed rugby?

As part of the Women and Girl's strategy (2018), aligned to the WRU Community Strategy the decision was made in March 2020 to lower the age of mixed rugby to U11 from Under 13s –

- Currently we lose a considerable amount of players from the ages U11s-U12s. We
  also lose players in season and again between U12-13s. See below reg data from
  season 18/19 to 19/20. There is a considerable drop off going into this season also.
- Increased provision and supportive pathway to aid in the retention of players at U12's
- To be fit for increased demand in the game by developing a single sex pathway at secondary school ages
- Reflective of insight in the female sport and needs including education sport trends where sport is mixed at primary and single sex in secondary
- Pre-empt potential safeguarding and player welfare risks in a changing society.
- To align to the other 3 home Nations

2 What are the aims for the future and what will this change bring?

The aim here is to increase the resource in the female game in an attempt to retain more players through the pathway and hit our goal of 10,000 actively registered females playing habitually in Wales over the next 5 years. By servicing the players in a single sex pathway we can pool resource into the female hubs to ensure all female players continue in a pathway that is right for the future of the female game. Players remove themselves from the game at these age groups with the offering of mixed rugby being the only provision from September until March. We see a spike in re-registration on the launch of the female season in the March time.

The ultimate aim would be for all ages to be single sex (like football) with 30,000+ females playing the game at varying ages in our pathway in our circa 300 clubs in Wales. This is a goal that will take a considerable amount of time to achieve.

3 How did we make the decision?

Conversation started 17/18 season around the current pathway and its capability to support the development of the female game in Wales. Key topics at that time;

- Concerns raised by the rugby community around the drop off by the end of the
   U13 season and the returns over the summer.
- Increased ask for winter provision in female hubs. Demonstrated this year in a large increase of sides playing in WRU U15s and 18s competition.
- Figures above around loss to the game at the point of decision making below

This prompted a 3 month Consultation process where we spoke to Clubs, WRU Female Hubs, Schools, Partners, other governing bodies and internal staff. We also held consultation in schools with 'rugby active' players some who only played in school others in a mixed setting were consulted and girls in WRU Female hubs where they were dual registered to the hub and mixed rugby club. We also conducted a survey sent to WRU Member clubs by the District GMGs in December 2019 that received 595 responses. Final proposal was presented to board as and process followed below.

- Signed off by WRU CGSB in March 2020 for implementation in September 2020.
- CGSB in June of 2020 to extended implementation to September 2021 in light of the COVID 19 Pandemic
- Following the return to play the WRU wanted to ensure we gave time to those players to return to the game and extended it again to registration renewal 2022 to start in September of 2022. This was announced in December 2021 to give over 6 month's notice of the changes.
  - 4 How will it grow the female game?

This is part of the wider investment and growth in resource of the female game in Wales. If we retain the potential lost 50% of players into next season we can create a better provision for female players in the ages. This isn't the only change as a result of this consultation. We've moved to 2 year bandings following conversations with players and key members of the rugby community highlighting the gap was too big and off putting for younger players having to play up 3 years on occasions. The change comes at a time where there are 20% more females playing the game with the numbers at the traditional single sex pathway ages of U15's & 18s growing (From 26-42 over the pandemic)

## 5 What are other countries doing?

All of the other 3 nations in the home nations (RFU, SRU & IRFU) have adopted the change. Also other sports in Wales are reflective of this in their mixed pathways with limited number going into the secondary schools. We are the only collision sport (to our knowledge) that allow mixed sport to this age.

Hi all,

England RFU has a quite inclusive <u>transgender and non-binary policy</u>, although I believe they are in consultation now, but that can be used as an example of inclusive practice. British Ice Hockey (see <u>Transgender Policy</u>), Roller Derby (also see <u>WFTDA</u>) and British Kickboxing Council (<u>quote</u>: "Trans people have every right to participate in sport at ALL levels without discrimination"; also see <u>Gender Diversity Focus Group here</u>) have policy and guidelines for inclusion of transgender women that are also more in line with WG policy aim.

We will have a proper look at the WRU Policy document properly, but, for now, in the WRU Policy the main barriers are around:

- Community Age Grade Female Game under 12-18;
- Community Adult Female Game

In the above two categories, a blanket exclusion is suggested in the WRU draft Policy. However, for Male Games, they suggest a case-by-case approach:

"If the player's sex recorded at birth is female, and the player identifies as transgender, non-binary or gender fluid, the player may play if:

- their parent or guardian (or such other appropriate adult) provides their written consent, in the form prescribed by the WRU to the relevant club or school;
- an appropriate risk assessment is carried out by the club or school which the player is representing in the form approved by the WRU;
- the WRU is notified prior to the player participating in the contact rugby activity"

The latter approach is probably not a perfect one either, but it is likely a better one than the blanket exclusion from Female Games, and could probably be suggested for the Female Games as well. This will help change the overall narrative, with inclusion as the starting point. It would align more to our overall Policy Aims.

The Policy should probably cover something around privacy or protection of data and identity for transgender people, as they may not be "publicly out" or out to their family or parents. For instance, if they request a signed form from parents, an example could be: "where this is not forthcoming the consent of the Player alone may be acceptable in accordance with the principle of Gillick Competency".

The Appeal Process is also a good initiative in the Policy. Although it may risk putting extra pressure on clubs and trans young people and expose to extra scrutiny or unwanted exposure, but it could be improved in terms of safeguarding measures around it. Although if the starting point is inclusion, then the risks of exposure are also reduced.

If/when there are concerns around testosterone levels for adults, there are some useful information in the England RFU policy document.

These are just some initial thoughts, and Emily and I can certainly provide more comments soon.

Dear Rob,

We are writing to you regarding your recently published transgender policy from our respective ministerial portfolios for social justice (including LGBTQ+ equality), and sport. We are concerned by the blanket exclusion of trans women and girls from rugby that your policy recommends. The Welsh Government believes that decisions on transgender people's participation in any part of society should come from a starting point of inclusion. LGBTQ+ rights, including trans rights, are human rights. Sport should be for everyone. A place where everyone can take part and where everyone is treated with kindness, dignity and respect. Our preferred position is to follow a case-by-case approach, rather than a blanket exclusion of transgender people.

We acknowledge that you have engaged with officials in both our departments to advise that this policy was in development. It would be useful to understand why the WRU feels it needs a policy of this nature, one that does not start from a point of inclusivity or use a case-by-case approach, and why at this time, given there are no registered transgender players in the community game in Wales. It would also be useful to know why the policy has a different approach for the treatment of trans men and trans women.

You have said that in coming to your stated policy position you engaged across the community. We would like to understand which organisations or communities you consulted with during the development of this policy, and what their respective views were.

If it would help, we would be happy to meet prior to receiving a formal response to this letter.

Dear member club,

I know you will have been shocked and appalled by the allegations in the BBC programme broadcast on Monday night and I am sorry to see how individuals who have worked for us felt. Our culture was not where it needed to be, when we have employees not feeling confident enough to speak up between 2017 and 2019.

Following this programme we will, again, review the process and procedures we have in place to make sure all staff feel safe and supported in speaking up about anything that makes them feel uncomfortable.

The WRU knows it has fallen short in presenting Welsh rugby to the world in the best light. We have fallen short of the high standards I expect.

I strongly condemn the use of racist, homophobic or sexist language of any kind and state in the strongest possible terms that racism, homophobic, sexist or bullying behaviour has no place in Welsh rugby. We strive to maintain the very highest standards at all times and present a governing body which makes the whole of Wales proud.

We have consulted with our staff and we will re-examine our structures and procedures to make sure our employees find a business that is caring and sensitive to their needs and welfare and creating a safe and secure environment for everyone that comes into contact with us.

We will use the feedback we are currently experiencing to improve, we will listen and learn from what we are hearing and continue to work hard on ensuring Welsh rugby is a game for all with equality, diversity and inclusion at its heart.

The advancement of the women's and girl's game is a central part of WRU strategy and will continue to be so at both professional and community levels.

I cannot turn back the clock but I promise you we will start work on making necessary changes immediately. I will not lead an organisation which would walk past or excuse any of the behaviour described. I will not stand by and watch a culture which falls below the high standards we set.

We will re-examine how we behave in all quarters of the WRU, we will never be complacent in this area, not on my watch.

Much of the recent comment has been difficult to hear but I implore anyone, anywhere throughout the game who is affected by any of the issues raised to contact us immediately.

I care deeply about this subject, the WRU cares deeply and we will act to change wherever we find fault, genuine complaint or grievance.

We will do better.

- SP informed officials on Friday on the BBC documentary being aired on Monday evening (23 Jan). He outlined some of the information likely to come out but full detail was unknown. Some information was already in the press.
- SP provided some context around the individual cases that had gone through an internal process and via an external legal firm. There was a high degree of frustration by WRU around the BBC reporting and the lack of balance offered.
- SP emphasised that sexism, misogyny and racism has no role in the WRU and was determined to clarify the steps it had taken and future action.
- DM welcomed being informed of the issues being raised ahead of the
  documentary and highlighted that the focus should be on action to restore trust in
  the organisation. The clustering of individual cases was extremely damaging and
  the link being made to the wider culture of the organisation. There was also a link
  between the cases being to be of detriment to the development of the women's
  game.
- There was a discussion about the call in the documentary around establishing an independent body to oversee complaints about Wales' sports governing bodies.
   There was no detail around the proposal at this stage and this would require further consideration.
- WG and WRU agreed to maintain contact and further discussion following the documentary being aired.

- DM highlighted that she wants to see a functioning governing body. WG is supportive of their efforts to restore confidence in the organisation and put a plan in place to do that. It is for the WRU to do that.
- DM highlighted the FM's comments in Plenary yesterday. DM has a Topical Question in the afternoon which with draw out the views of Senedd Members in greater detail.
- DM stated that she will be encouraging the WRU to release the report into the
  women's game and she would also welcome sight of their wider governance
  review to see for herself the range of reforms they have previously considering.
  SP said he already gave commitments in yesterday's media interview and
  therefore a positive response is expected.
- DM recalled her previous discussion with SP and leuan Evans around the

Dear Dawn,

I am writing to you formally, in your capacity as the Minister for Sport to raise grave concerns I have about the Welsh Rugby Union. There is a deep seated culture of sexism within the WRU which I am afraid will soon become public and that will paint the Welsh Government and those that fund the WRU such as the sponsors and Sport Wales in a negative light. I am concerned that the WRU are not held to account for their behaviour and for their actions as their governance system is archaic and this has resulted in problems within the institution not being dealt with properly and transparently. We have seen this in the review of women's rugby which was completed last year. This document has not been published and there has not been an apology to women who have played and that are playing currently for the way in which they have failed to be the custodians of the game that they had set out to do when they took over the management of the women's game.

My concerns are reflected in the resignation of Amanda Blanc from the WRU Executive Board, after only seeing out 2 of her 6 year tenure. Amanda is the current CEO of Aviva and one of the United Kingdom's high achieving women. Concerns also have been raised anonymously in the media, you may have seen the report in the Daily Mail in March regarding a sex discrimination case which is to be brought in front of a judge in the early autumn. These are only two of a number of cases that have been brought to my attention. I have been unable to speak to and contact the other women myself, but I am very aware of someone in the media having built a comprehensive list of women who are all prepared to go public. From within the WRU, I have spoken to 3 people who have shared my concerns and more concerningly confirmed what I already knew about the organisation.

This is not just a case of one or two people having a spat with the WRU, this is a huge problem on the scale of racism in Yorkshire cricket. I am asking you to speak to these individuals in confidence in order to collaborate the concerns I have raised in this email. As an ambassador of a local girls hub, I have a duty as their MP to ensure that the mistakes of the past and present do not hinder the future careers of women and girls in rugby, and that they are safe to work in the world of rugby and play the sport that they love.

### Dear Tonia

Thank you for your correspondence dated 9 May 2022 raising a number of concerns regarding the Welsh Rugby Union.

There have been recent positive developments in the women's game in Wales to address longstanding issues. However, I am very clear that this is only the beginning of the journey. The WRU still has much to do and I expect them to continue to build on this progress leading to this year's World Cup and beyond. It will be an area I will continue to press for improvements in my discussions with the Chief Executive, and others.

My understanding is the foundation for many of these recent changes we have seen in the women's game have been driven by the review undertaken last year. Whilst I have not seen the report directly, I recognise the concerns raised about the report not being made public and I have engaged with the WRU to understand their approach. It is my understanding that it was always intended to be an internal report to allow consultees and the authors the freedom to be candid in their views of the issues and the changes needed in the women's game. A public-facing report may not have reached the same conclusions and to release the report now may betray the confidences of those involved. However, in moving the game forward, it is critical that the WRU demonstrates that the approach it is taking is being developed with players and stakeholders and that their actions reflect that partnership working.

Whilst I am unable to comment on an ongoing employment tribunal, we should be very clear that any individual or groups wishing to raise complaints or concerns should follow the organisation's complaints or whistleblowing processes in the first instance, before deciding whether or not to escalate matters further.

I have not received any direct representations on any such concerns you highlight.
