Thank you for your request which I received on 9 February 2023. I have set out at Annex 1, the questions you submitted.

With regard to your question who was the 'media buying agency' for each of the years, I can confirm this is Golley Slater.

For the remaining parts of your question relating to financial spend on notices (as set out at Annex 1), I have reached the conclusion that it will cost more than the appropriate limit established in the Freedom of Information and Data Protection (Appropriate Limit and Fees) Regulations 2004 to consider your request. The appropriate limit specified for central government is £600. When calculating whether or not your request exceeds appropriate limit, I am allowed to consider the time it is likely to take to establish if we hold the information, locate the information, retrieve the information and extract it. If these tasks are estimated to take more than 24 hours of working time, the limit will have been exceeded.

For the period 2016 – 2022, there are 13,208 individual entries on the media buying financial report. For the year 2022 alone, there are 1878 entries.

Taking approximately 3 minutes to review each of the lines from the 2022 report alone and then to locate, extract and retrieve that which falls within the scope of your request would exceed the limit (1878*3/100=56.34 hours).

You may wish to refine your request by narrowing its scope by being more specific about what information you particularly wish to obtain e.g. focussing on a specific type of notice (not a broad range or broad description) combined with a narrower time frame. Any reformulated question will be treated as a new request for information.

If you are dissatisfied with the Welsh Government's handling of your request, you can ask for an internal review within 40 working days of the date of this response. Requests for an internal review should be addressed to the Welsh Government's Freedom of Information Officer at:
