Thank you for your request for information which I received on 17 March.

Your request

You asked:

How many businesses benefited from the £1million business start-up fund announced in March last year?

Our Response

I can confirm that the Welsh Government holds the information you have requested.

The Business Wales Barriers to Start-up Grant is to enable economically inactive and unemployed individuals aged over 25 years to start a new business in Wales.

The grant particularly targets individuals that are facing barriers to business start-up and the employment market. To date we have approved 535 applications to support individuals to start a business and have awarded £1,003,320 of grants.

Next steps

However, please note that the Commissioner will not normally investigate a complaint until it has been through our own internal review process.

The request you sent me contains personal information about you - for example, your name. We will only use this personal information to deal with your request and any matters which arise as a result of it. Your personal information will then be disposed of securely.

- to require us to rectify inaccuracies in that data
- to (in certain circumstances) object to or restrict processing

- to (in certain circumstances) data portability
- to lodge a complaint with the Information Commissioner's Office (ICO) who is our independent regulator for data protection
