Gorchymyn Cefnffordd yr A483 (Y Groes, Powys) (Terfyn Cyflymder 20 mya Rhan-amser) 2018

*Gwnaed**2 Mai 2018**Yn dod i rym**4 Mai 2018*

Mae Gweinidogion Cymru, sef yr awdurdod traffig ar gyfer y darn perthnasol o Gefnffordd yr A483 Abertawe i Fanceinion, drwy arfer y pwerau a roddir iddynt gan adran 84(1)(c), (1A) a (2) o Ddeddf Rheoleiddio Traffig Ffyrrd 1984(1), ac ar ôl ymgynghori â Phrif Swyddog Heddlu Dyfed-Powys, yn gwneud y Gorchymyn hwn.

Enwi, Cychwyn a Dehongli

1. Enw'r Gorchymyn hwn yw Gorchymyn Cefnffordd yr A483 (Y Groes, Powys) (Terfyn Cyflymder 20 mya Rhan-amser) 2018 a daw i rym ar 4 Mai 2018.

2. Yn y Gorchymyn hwn:

ystyr "cerbyd esempt" ("exempted vehicle") yw:

- (a) unrhyw gerbyd sy'n cael ei ddefnyddio gan y gwasanaethau brys at y dibenion a ddisgrifir yn adran 87 o Ddeddf Rheoleiddio Traffig Ffyrrd 1984(2);

- (1) 1984 p.27; amnewidiwyd adran 84(1) gan adran 45(2) o Ddeddf Traffig Ffyrrd 1991 (p.40). Amnewidiwyd adran 84(2) gan baragraff 61 o Atodlen 8 i Ddeddf Ffyrrd Newydd a Gwaith Stryd 1991 (p.22). Yn rhinwedd O.S. 1999/672 ac adran 162 o Ddeddf Llywodraeth Cymru 2006 (p.32) a pharagraff 30 o Atodlen 11 iddi, mae'r pwerau hyn yn arferadwy bellach gan Weinidogion Cymru o ran Cymru.
- (2) Diwygiwyd adran 87 gan baragraff 55 o Atodlen 1 i Ddeddf y Gwasanaethau Tân ac Achub 2004 (p.21), paragraff 42 o Atodlen 4 i Ddeddf Trosedd Cyfundrefhol Difrifol a'r Heddlu 2005 (p.15), paragraff 29(2) o Atodlen 8 i Ddeddf Trosedd a'r Llysoedd 2013 (p.22), ac adran 50(4) a (5) o Ddeddf Dadreoleiddio 2015 (p.20).

ROAD TRAFFIC, WALES

The A483 Trunk Road (Crossgates, Powys) (Part-time 20 mph Speed Limit) Order 2018

*Made**2 May 2018**Coming into force**4 May 2018*

The Welsh Ministers, as traffic authority for the relevant length of the A483 Swansea to Manchester Trunk Road, in exercise of the powers conferred upon them by section 84(1)(c), (1A) and (2) of the Road Traffic Regulation Act 1984(1) and after consultation with the Chief Officer of Dyfed-Powys Police, make this Order.

Title, Commencement and Interpretation

1. The title of this Order is the A483 Trunk Road (Crossgates, Powys) (Part-time 20 mph Speed Limit) Order 2018 and it comes into force on 4 May 2018.

2. In this Order:

"exempted vehicle" ("cerbyd esempt") means:

- (a) any vehicle being used by the emergency services for the purposes described in section 87 of the Road Traffic Regulation Act 1984(2);

(1) 1984 c.27; section 84(1) was substituted by the Road Traffic Act 1991 (c.40), section 45(2). Section 84(2) was substituted by the New Roads and Street Works Act 1991 (c.22), Schedule 8, paragraph 61. By virtue of S.I. 1999/672, and section 162 of, and paragraph 30 of Schedule 11 to, the Government of Wales Act 2006 (c.32), these powers are now exercisable by the Welsh Ministers in relation to Wales.

(2) Section 87 was amended by the Fire and Rescue Services Act 2004 (c.21), Schedule 1, paragraph 55, the Serious Organised Crime and Police Act 2005 (c.15), Schedule 4, paragraph 42, the Crime and Courts Act 2013 (c.22), Schedule 8, paragraph 29(2) and the Deregulation Act 2015 (c.20), section 50(4) and (5).

(b) unrhyw gerbyd sy'n cael ei ddefnyddio at ddibenion y llynges, y fyddin neu'r llu awyr ac sy'n cael ei yrru gan berson sydd am y tro yn ddarostyngedig i orchymynion aelod o huoedd arfog y Goron, sy'n aelod o'r Lluoedd arbennig—

- (i) ac sydd wedi ei hyfforddi i yrru ar gyflymderau uchel ac sy'n gweithredu wrth ymateb, neu wrth ymarfer ymateb, i argyfwng diogelwch gwladol; neu
- (ii) at ddiben hyfforddi person i yrru cerbydau ar gyflymderau uchel;

ystyr "y gefnffordd" ("the trunk road") yw Cefnffordd yr A483 Abertawe i Fanceinion;

ystyr "luoedd arbennig" ("special forces") yw'r unedau hynny o'r Lluoedd arfog y mae Cyfarwyddwr y Lluoedd Arbennig yn gyfrifol am gynnal eu galluoedd neu sydd am y tro yn ddarostyngedig i reolaeth weithredol y Cyfarwyddwr hwnnw.

Cyfngiad

3. Ni chaiff neb yrru unrhyw gerbyd modur, ac eithrio cerbyd esempt, yn gyflymach nag 20 milltir yr awr ar y darn o'r gefnffordd yn y Groes, Powys, sy'n ymestyn o bwynt 102 o fetrau i'r de o ganolbwyt cylchfan yr A483/A44 hyd at bwynt 38 o fetrau i'r de o ganolbwyt ei chyffordd â Guidfa Meadows, gan gynnwys cerbytffordd gylchredol y gylchfan.



(b) any vehicle being used for naval, military or air force purposes and being driven by a person for the time being subject to the orders of a member of the armed forces of the Crown, who is a member of the special forces—

- (i) in response, or for practice in responding, to a national security emergency by a person who has been trained in driving at high speeds; or
- (ii) for the purpose of training a person in driving vehicles at high speeds;

"special forces" ("luoedd arbennig") means those units of the armed forces the maintenance of whose capabilities is the responsibility of the Director of Special Forces or which are for the time being subject to the operational command of that Director;

"the trunk road" ("y gefnffordd") means the A483 Swansea to Manchester Trunk Road.

Restriction

3. No person may drive any motor vehicle, other than an exempted vehicle, at a speed exceeding 20 miles per hour on the length of the trunk road at Crossgates, Powys that extends from a point 102 metres south of the centre-point of the A483/A44 roundabout to a point 38 metres south of the centre-point of its junction with Guidfa Meadows, including the circulatory carriageway of the roundabout.


4. The restriction in article 3 applies only during such times and to such extent as indicated by traffic signs.

Mae Gweinidogion Cymru wedi gwneud Gorchymyn drwy arfer eu pwerau o dan adran 84(1)(c), (1A) a (2) o Ddeddf Rheoleiddio Traffig Ffyrdd 1984, sy'n dod i rym ar 4 Mai 2018.

Effaith y Gorchymyn yw cyflwyno terfyn cyflymder 20 mya rhan-amser ar y darn o gefnffordd yr A483 yn y Groes, Powys, sy'n ymestyn o bwynt 102 o fetrau i'r de o ganolbwyt cylchfan yr A483/A44 hyd at bwynt 38 o fetrau i'r de o ganolbwyt ei chyffordd â Guidfa Meadows, gan gynnwys cerbytffordd gylchredol y cylchfan, er mwyn gostwng cyflymder traffig a hybu diogelwch cerddwyr ger Ysgol Gynradd y Groes. THE A483 TRUNK ROAD (CROSSGATES, POWYS) (PART-TIME 20 MPH SPEED LIMIT) ORDER 2018

The Welsh Ministers have made an Order in exercise of their powers under section 84(1)(c), (1A) and (2) of the Road Traffic Regulation Act 1984, which comes into force on 4 May 2018.

The effect of the Order is to introduce a part-time 20 mph speed limit on the length of the A483 trunk road at Crossgates, Powys that extends from a point 102 metres south of the centre-point of the A483/A44 roundabout to a point 38 metres south of the centre-point of its junction with Guidfa Meadows, including the circulatory carriageway of the roundabout, in order to reduce the speed of traffic and promote pedestrian safety near Crossgates Primary School. This reduced speed limit is only expected to apply for limited periods of the day during school term time.
