- 5. Have any of the people selected previously applied to go on the BCUHB Board or any other Public Appointment in Wales but have been unsuccessful;
- 6. A copy of their full terms and conditions of engagement to include financial information, role, time allocation etc.
- 7. The date on which the appointments were made;

The Governance Code on Public Appointments, 'section 3 The Role of Ministers' allows that in exceptional cases, Ministers may decide to appoint a candidate without a competition. Some individuals were already engaged in the Public Appointments process and therefore known to officials.

In line with the Governance Code on Public Appointments, 'section 3 The Role of Ministers', officials contacted Ministers and other stakeholders for names of individuals who should be approached.

Before the health board were escalated to Special Measures, Welsh Government officials approached 10 individuals regarding a direct, interim appointment to the Board.
