- How many times, dates and sanctions imposed on pharmacies in Holyhead and Bangor that closed during their contracted hours since December 2022 until now, you are interested in Tesco Holyhead and Bangor.
- Since December 2022, how many pharmacy branch closures in Holyhead and Bangor Gwynedd, have been reported as closed during its pharmacy's core and supplementary hours?
- Please provide for each instance of a pharmacy closure:
 - The date on which this occurred
 - The name of the pharmacy at which this occurred
 - The address of the pharmacy at which this occurred
 - The number of hours for which the pharmacy was closed
 - The times between which the pharmacy was closed
 - The reason(s) cited for the closure by the person or organisation reporting it, if any
 - The expected hours of pharmacy opening according to its core hours as per the terms of service stipulated
 - The expected hours of pharmacy opening according to their contract
 - Details of any corrective action taken / sanction imposed / fines/ levies
