ATISN 17476 – Anti-racism Wales Action Plan

Thank you for your request which I received on 11th May 2023.

1) You asked for information and clarification on terminology used within "The Race Equality Action Plan for Wales" and asked for a comprehensive definition of the term "White Privilege".

2) You asked for evidence of "automatic privileges" held by white people and for any accompanying studies to support this in terms of position, resources, influence, authority, and historical beliefs.

3) You also asked for the reasoning behind removing the term "White Privilege" from the final version of the Anti-racist Wales Action Plan.

4) Lastly, you cited the number of times you found the word 'White' recorded with a lowercase w in contrast with the number of times 'Black or 'Asian' are recorded with a lowercase b or a lowercase a respectively, and

a) asked for the intent and reasoning behind using a lower case "w" when referring to White people.

b) asked if the Anti-racist Wales Action Plan will be amended.

c) And asked for a timeframe for any such amendments.

Your first question does not constitute a Freedom of Information request since it does not pertain to recorded information held by the Welsh Government. However, you do include the definition of 'White Privilege' from the original Race Equality Action Plan in your letter and acknowledge that this term is not included in the finalised version of the Anti-racist Wales Action Plan.

In terms of evidence of "automatic privileges" held by white people, the Anti-Racist Wales Action Plan was developed drawing on a range of evidence and lived experience. I have provided links to published information summarising this evidence:

The term "White Privilege" is used in the draft Race Equality Action Plan but not in the Anti-racist Wales Action Plan. The omission of the term does not equate to active removal. Indeed, there are many differences of note between the Race Equality Action Plan and the final Anti-racist Wales Action Plan, and the information for each of the changes made between drafts is not information formally held.

Lastly, in the use of capital and lowercase lettering in each instance, there is nothing deliberate in the variation However, we take note of these inconsistencies. The Antiracist Wales Action Plan is due to be revised in 2024 in accordance with its twoyearly review of goals and actions and this would be a good opportunity for standardisation.
