## **ATISN 18575 – DB – UK Household Support Fund**

Thank you for your request, which I received on 7<sup>th</sup> June 2023. You asked for details regarding the allocation of funding by the Welsh Government in respect of consequential funding resulting from the operation of the Barnett Formula, specifically UK Government spending in the financial year 2022-23 relating to the UK Household Support Fund.

I can confirm that the Welsh Government received a total of £49.530m in respect of the UK Household Support Fund in 2022-23:

- £24.765m in the Spring Statement from consequentials relating to the Department of Work and Pensions; and
- £24.765m non-Barnett funding in Supplementary Estimates.

Changes to funding in England on programmes that are devolved in Wales result in changes to our block grant via the Barnett formula. However, those changes do not determine what the block grant should be spent on. Welsh Ministers, with the Senedd's approval, decide how to allocate the Welsh Government's budget, which includes funding from Barnett consequentials, in line with its priorities as part of the budget process.

In line with the principles of the devolution settlement, consequentials are added to overall reserves and these reserves are then allocated in line with devolved priorities, rather than ring-fenced for use on the policy area or initiative from which they were generated. As a result, it is not possible to specify precisely where this consequential funding was spent in the 2022-23 financial year because it cannot be disaggregated from other funding contained within reserves.

All funding allocations made by Welsh Ministers in the financial year 2022-23 can be seen in the relevant budgetary documentation. Links to those documents are attached below.
