

## DEDDF CYNLLUNIO GWLAD A THREF 1990

### GORCHYMYN CAU PRIFFYRDD (RESOURCE HOUSE, PENTRE GARDENS, CAERDYDD) 2023

Mae Gweinidogion Cymru wedi gwneud Gorchymyn o dan adran 247 o Ddeddf Cynllunio Gwlad a Thref 1990 ("Deddf 1990") i awdurdodi cau'r darn o briffordd a ddisgrifir yn Atodlen 1 i'r Hysbysiad hwn. 
Caiff unrhyw berson a dramgwyddir gan y Gorchymyn, ar y sail:

## TOWN AND COUNTRY PLANNING ACT 1990

### THE STOPPING UP OF HIGHWAYS (RESOURCE HOUSE, PENTRE GARDENS, CARDIFF) ORDER 2023

The Welsh Ministers have made an Order under section 247 of the Town and Country Planning Act 1990 ("the 1990 Act") to authorise the stopping up of the length of highway described in Schedule 1 to this Notice. The Welsh Ministers are satisfied that the stopping up is necessary, and it will be authorised only in order to enable the development to be carried out in accordance with planning permission granted under Part 3 of the 1990 Act by the County Council of the City and County of Cardiff on 29 November 2019 with reference 18/02622/MJR and described in Schedule 2 to this Notice.

The Stopping Up of Highways (Resource House, Pentre Gardens, Cardiff) Order 2023 ("the Order") ceases to have effect if planning permission in respect of the development expires or is revoked.

Copies of the Order and the deposited plan may be inspected free of charge during normal office hours at Grangetown Hub Library, Havelock Place, Grangetown, CF11 6PA, or may be obtained free of charge from the address below quoting reference qA11611541.

If a person is aggrieved by the Order, on the grounds that:

- a. it is not within the powers of the 1990 Act; or
- b. a procedural requirement of the 1990 Act has not been complied with;

that person may, within 6 weeks of 19 July 2023 make an application for the purpose to the High Court.

**SCHEDULE 1**  
**(All measurements are approximate)**

**Length of the highway to be stopped up**

A rectangular-shaped length of highway located on the south-eastern corner of Pentre Gardens, Penarth Road, Cardiff, heading west from its junction with Taffs Mead Embankment, with a maximum length of 29 metres and a maximum width of 2 metres, and marked with zebra hatching on the deposited plan.

**The Development**

The development will enable the erection of a residential development of 74 units with associated infrastructure and engineering works at Resource House, 54B Penarth Road, Grangetown, Cardiff, CF11 6NG.
