Thank you for your request which I received on 26 July 2023. You asked for the information as shown at Annex 1.

Please find attached details of the appeals under Section 39 of the Planning (Listed Buildings and Conservation Areas) Act 1990 dealt with by the Planning and Environment Decisions Wales (PEDW) and previously Planning Inspectorate Wales, in the last 5 years.

In summary;

1. 9 appeal decisions have been issued and 1 is on-going
2. The number of appeals successfully appealed – 1
3. Mr A McCooey has undertaken 4 of the 9 decisions issued and
4. 1 of the 4 appeals undertaken by Mr McCooey was successfully appealed.
