Compatibility Assessments

The purpose of this appendix is to present how the assessment process that will be undertaken for the Strategic Road Network (SRN) as part of the Wales Roads Review, which will subsequently be included within the NTDP, is compatible with the ISA Framework, which will assess the priorities and programmes in the NTDP. The WelTAG process will be followed for each road project, and assessed as part of an expert panel, to determine whether roads projects are necessary.

Wales Roads Review

In June 2021, the Deputy Minister for Climate Change announced that there would be a pause on all new road schemes while the existing pipeline of schemes is reviewed due to the Welsh Government and many Local Authorities in Wales declaring a climate emergency.

Planning policy, as set out in Future Wales (February 2021), sets an aim for people to live in places where travel has low environmental impact and low emissions, with reduced reliance on private vehicles. The Wales Transport Strategy (March 2021), sets out how Welsh Government plans to reduce the number of journeys taken by private cars and increase the number of people walking, cycling and using public transport. The Net Zero Wales Carbon Budget 2 (October 2021) sets an aim to reduce the number of car miles travelled per person by 10% by 2030 (from 2019), and to increase the proportion of trips by sustainable modes (public transport and active travel) to 35% by 2025 and 39% by 2030.

The Roads Review examined the current pipeline of road investment by Welsh Government to assess whether it is aligned with these new policies.

Following the review, four purposes for which road investment can be justified have been set out:

- To support modal shift and reduce carbon emissions. This is about ensuring that
 future roads investment does not simply increase the demand for private car travel.
 Instead, we need to deliver schemes that contribute meaningfully to modal shift, which
 will require different approaches in different parts of Wales.
- 2. **To improve safety through small-scale changes**. Safety on the road network must be paramount. Investments for safety should focus on specific safety issues to be addressed (rather than wider road improvements and increases in road capacity). Speed limits should be considered as one of the primary tools for improving safety.
- 3. To adapt to the impacts of climate change. Climate change is already having an impact on our road network and is likely to become an increasing issue in future decades. Road investment can be justified to adapt for these circumstances to ensure roads can continue to function and contribute meaningfully to modal shift.
- 4. To provide access and connectivity to jobs and centres of economic activity in a way that supports modal shift. In particular, new and existing access roads will be

necessary to connect new developments, including Freeports, to the existing network. The location of new developments needs to be consistent with Future Wales / PPW11, which includes the principle of maximising the opportunity of access by sustainable means and should be designed to prevent 'rat-running'.

Going forward the Welsh Transport Appraisal Guidance (WelTAG), which is currently being reviewed, will ensure that all transport projects are aligned to the delivery of WTS ambitions and priorities.

Nine criteria were developed by the panel to enable structured consideration of how well each scheme aligns with Welsh Government policy and meets the national well-being goals. Criteria 1-3 look at the scheme development process; criterion 4 looks at the impact of the scheme on CO₂ emissions; criteria 5-8 relate to the Wales well-being goals; and criterion 9 examines whether the scheme is robust to different possible futures.

A compatibility assessment has been carried out between the ISA Objectives and the nine criteria to show how the principles of the Wales Roads Review aligns with the ISA Framework.

WelTAG Guidance: Integrated Impact Assessment

The Integrated Impact Assessment Report is produced as part of the WelTAG process as an overview of how the project could impact on well-being and what action could be taken to avoid, reduce or mitigate any harmful impacts. Although it is primarily qualitative, an Integrated Impact Assessment should be supported by quantitative data wherever possible.

An Integrated Impact Assessment report has two purposes:

- The first is that it can help design a better scheme that delivers wellbeing benefits. It helps to anticipate and hopefully avoid any unintended impacts or harm that the project may have.
- Secondly, it shows how the project has taken well-being into account.

The four ambitions of the WTS (Good for People and Communities, Good for the Environment, Good for the Economy and Places in Wales and Good for Culture and the Welsh Language) have been used to structure the Integrated Impact Assessment report guidelines.

The table below demonstrates how the WelTAG guidance and the ISA Framework are compatible as assessment frameworks. It establishes that, although the questions follow a different format, the considerations covered are similar.
