GORCHYMYN CAU PRIFFYRDD (WISTERIA COURT, YSTAD MAESGWYN, WRECSAM) 2023

TOWN AND COUNTRY PLANNING ACT 1990

THE STOPPING UP OF HIGHWAYS (WISTERIA COURT, MAESGWYN ESTATE, WREXHAM) ORDER 2023

The Welsh Ministers have made an Order under section 247 of the Town and Country Planning Act 1990 ("the 1990 Act") to authorise the stopping up of the lengths of highway described in Schedule 1 to this Notice. The Welsh Ministers are satisfied that the stopping up is necessary, and it will be authorised only in order to enable the development to be carried out in accordance with planning permission granted under Part 3 of the 1990 Act by Wrexham County Borough Council on 5 June 2023 with reference WROP/2022/0854 and described in Schedule 2 to this Notice.

The Stopping Up of Highways (Wisteria Court, Maesgwyn Estate, Wrexham) Order 2023 ("the Order") will cease to have effect if planning permission in respect of the development expires or is revoked.

Copies of the Order and the deposited plan may be inspected free of charge during normal office hours at Wrexham County Borough Council, Economy & Planning Department, Guildhall, Wrexham LL11 1AY, or may be obtained free of charge from the address below quoting reference qA1849705.

If a person is aggrieved by the Order, on the grounds that:

- a. it is not within the powers of the 1990 Act; or
- b. a procedural requirement of the 1990 Act has not been complied with;

that person may, within 6 weeks of 13 September 2023 make an application for the purpose to the High Court.

Lengths of highway to be stopped up

An irregularly shaped length of highway comprising footway providing access to Wisteria Court Care Home, situated between Lilac Way and Primrose Way at Maesgwyn Estate in Wrexham, having a total area of 15 square metres, shown by zebra hatching and given the reference 'A' on the deposited plan.

An irregularly shaped length of highway comprising footway providing access to Wisteria Court Care Home, situated between Lilac Way and Primrose Way at Maesgwyn Estate in Wrexham, having a total area of 51 square metres, shown by zebra hatching and given the reference 'B' on the deposited plan.

An irregularly shaped length of highway comprising footway providing access to Wisteria Court Care Home, situated between Lilac Way and Primrose Way at Maesgwyn Estate in Wrexham, having a total area of 18 square metres, shown by zebra hatching and given the reference 'C' on the deposited plan.

The Development

The development will enable the remodelling of sheltered housing scheme to provide 26 independent living units and proposed ground floor extension at Wisteria Court, Maesgwyn Estate, Wrexham LL11 2AJ.
