

**GORCHYMYN CEFNFFORDD YR A5 (CILFAN
I'R GORLLEWIN O BORTHAETHWY, YNYS
MÔN) (GWAHARDD CERBYDAU DROS DRO)
2023**

Mae Gweinidogion Cymru wedi gwneud Gorchymyn o dan adran 14 o Ddeddf Rheoleiddio Traffig Ffyrdd 1984. Mae angen y Gorchymyn er mwyn gwneud gwaith ar gefnffordd yr A5, neu gerllaw iddi, ym Mhont Menai, Ynys Môn.

Effaith y Gorchymyn yw gwahardd dros dro bob cerbyd, ac eithrio'r rhai a ddefnyddir ar gyfer y gwaith, rhag mynd ar y darn o'r gilfan sy'n gyfagos i gerbyttffordd tua'r gorllewin cefnffordd yr A5, 365 o fetrau i'r gorllewin o Gylchfan Shell yr A5, Porthaethwy ac 1km i'r dwyrain o Gyffordd 8A yr A55 (Carreg Brân), Ynys Môn.

Daw'r Gorchymyn i rym ar 16 Hydref 2023. Disgwylir y bydd y gwaharddiad dros dro yn weithredol o 05:00 o'r gloch ar y dyddiad hwnnw ac yn parhau mewn grym am gyfnod o 18 mis ar y mwyaf.

**THE A5 TRUNK ROAD (LAY-BY WEST OF
MENAI BRIDGE, ANGLESEY) (TEMPORARY
PROHIBITION OF VEHICLES) ORDER 2023**

The Welsh Ministers have made an Order under section 14 of the Road Traffic Regulation Act 1984, which is necessary to undertake works on or near the A5 trunk road at Menai Suspension Bridge, Anglesey.

The effect of the Order is to temporarily prohibit all vehicles, other than those being used for the works, from proceeding on the length of the lay-by adjacent to the westbound carriageway of the A5 trunk road, located 365 metres west of the A5 Shell Roundabout, Menai Bridge and 1km east of the A55 Junction 8A (Carreg Bran), Anglesey.

The Order comes into force on 16 October 2023. The temporary prohibition is expected to operate from 05:00 hours on that date and to remain in force for a maximum period of 18 months.
