The formal car parking bays and walls were still in situ when I visited the site on the 29<sup>th</sup> March 2023. Here is an image I took showing the extent of the clearance works, which shows that the central tree avenue has been felled along with some trees around the perimeter. The most recent google earth image appears to show the car park obscured by vegetation although the central avenue and perimeter trees are clearly evident prior to the clearance work being undertaken.

## Hi All,

Thank you for your email yesterday. The only times I could do today are between 1.30-2.30 or after 3.30. The only powers we have with regards to the registered park and garden are as statutory consultees in the planning system. There is no consent process for registered parks and gardens, so for works that do not require planning consent all we can offer is our advice. Designations, such as TPOs, listing, and scheduling can protect individual elements of designed landscapes, and in this case considering TPOs for the surviving trees of the Colvin landscape. We have a copy of the original planting plan and can help with identifying trees of historic significance.

I have also written to with our concerns about the damaging impacts of the work on the registered garden and have asked for them to engage with us before any further work is undertaken. We hope we can work together with yourselves and the owners but I have not heard back from them yet.

Following your site visit yesterday please could you provide us with Flintshire's response clarifying what has happened on site and what your recommendations are. Do we know what the owner's intentions for the site are? Cadw have been asked to provide a response to Ministers on the current situation.

I hope this provides you with enough information from our perspective but if a Teams meeting would still be helpful please let me know.

Further to the latest information you have sent through, I think it would be useful for colleagues here to meeting with you virtually to understand Cadw's perspective on this issue and the powers you have to intervene from the perspective of the Historic Park and Garden designation. We are not clear that the LPA has any powers top intervene as is set out for listed buildings in TAN24, as the TAN is silent on these designations.

We are carrying out a enforcement fact finding site visit this afternoon and have already advised the land owner to cease all works until we can determine what he is doing and what may need planning consent.





Dear

We have been consulted on a notice for a Tree Preservation Order (TPO) at the grade II registered historic park and garden at Shotton Steelworks Garden PGW(C)76(FLT). The formal notice states that the Council has made the order because the land is a Cadw Registered Historic Park and Garden containing trees that were planted as part of the garden's design and which also complement the setting of the listed office buildings. The trees are publicly visible and as a result of the above designations it is deemed that they afford significant amenity to the area. Moreover, due to concerns about ongoing tree felling it is considered expedient to make the Tree Preservation Order with immediate effect on a provisional basis. The

TPO boundary corresponds with the boundary of the registered historic park and garden

Cadw has registered the site for the survival of the layout, formal structure and much of the major planting of a formal garden and forecourt designed by the distinguished landscape architect Brenda Colvin (1897-1981) to complement the adjacent office buildings. A particular aim of the garden was to provide recreational space for the office workers. A garden existed at Shotton before Colvin's involvement and was integrated into her design and further enhanced by Colvin. Colvin's landscaping plans for Shotton survive and are held at the Landscape Institute Archive at the Museum of English Rural Life (MERL), University of Reading.

We support a TPO for the registered garden to protect the remaining trees of historic significance. It is my view that the TPO should be in place to protect trees that are of historic significance to the registered historic park and garden, including trees planted as part of Colvin's designs as well as those incorporated into her plans and any of significance that may have been planted since. However, lack of ongoing management has allowed many self-seeded trees to grow across the site distorting the original planting scheme and design intention. Trees that have grown up as a result of neglect and lack of site management are not therefore considered to be of historic significance to the designed landscape. Cadw would be happy to help identify trees of significance to the registered historic park and garden to inform the TPO.

#### Hi All,

Thanks for sending over the plans from \_\_\_\_\_. The extent of the masterplan covers all of the registered garden area, plus the adjacent land to the southeast.

Overall, the proposal to reinstate the registered gardens, including the bowling green and putting green, is positive but as I said last week, it's really important that we understand what remains of the original layout of the grounds (this includes the 1930s layout and the 1950s Colvin layout which enhanced the 1930s plan) before proposals are progressed any further. The first step would be for proposals are produce a Heritage Impact Assessment following Cadw's methodology Heritage Impact Assessment | Cadw (gov.wales) to cover the whole site. This should also include an assessment of existing planting across the site, which may form part of the HIA or be provided as a separate report, but which identifies trees and shrubs of significance to the original planting scheme.

Do we have or can we ask for a record of significant trees that have been removed (ie. trees forming part of the original gardens rather than self-sown)?

The adjacent land is proposed for use as a car park, which I understand it has been used for previously. The masterplan shows the area will be somewhat screened by tree planting and the existing lab building. Further planting in the parking area would further soften the expanse of tarmac. The proposed building/viewing gallery proposed to the rear of the lab building seems unlikely to cause major concerns for the setting of the registered garden, but this would depend on its design.

The masterplan shows the northeast corner of the registered garden (the former tennis court) as a storage area surfaced with crushed hardcore. This area lies within the registered garden and I would advise that this area is not developed for storage or vehicle auction use and is instead reinstated as garden.

Between the 1950s buildings, the masterplan shows a possible central atrium and new lift access in this location. I flag this as of concern as it has the potential to interrupt the axial design and significant view along the central axis of the garden.

To the immediate west of the John Summers building, on the site of a former building, a car park compound post workshop is proposed. This element is likely to be quite intrusive and I advise that alternative options are considered. Earth mounding and tree planting as shown in the Colvin plans could help screen proposals in this area. I've attached extracts of the Colvin setting out plan.

The low brick walls seem to have been retained in the proposed public car parking area to the south of the forecourt, and around the perimeter of the former car park to the west of the entrance road (proposed car parking compound pre workshop). As we discussed last week, we would like to see the low brick walls that have been removed from the former car park to the west of the entrance road reinstated, along with the planting.

The wire mesh fencing/post and board fencing up to 2.5m high across the site is likely to be intrusive and will need careful consideration.

We've looked at various options for the masterplan and have done a couple of iterations which is largely led by the unique nature of the new use of the site and how it will operate on a daily basis. We'd also really welcome some further understanding of the development surrounding the site and the changes to the road to the north as part of the Northern Gateway which is obviously outside the redline boundary but will impact the development.
