Thank you for your email received on 11 October 2023 which has been dealt with under the Freedom of Information Act (2000). You requested the following:

- How much funding/money has the Welsh Government provided to Health Boards, Local Authorities or direct to providers from the Welsh Government for the provision of the following Statutory Advocacy Services in 2022 and 2023:
 - Independent Mental Health Advocacy (IMHA)
 - Independent Mental Capacity Advocacy (IMCA)
 - Independent Professional Advocacy (IPA)
 - Statutory Advocacy for Children and Young People

Our Response

<u>Independent Mental Health Advocacy (IMHA) & Independent Mental Capacity Advocacy (IMCA)</u>

An additional £2.3m was made available from Welsh Government in 21-22, 22-23 and 23-24 to increase spending on advocacy to support the implementation of the Mental Capacity Act. This is in addition to funding for IMCAs and IMHAs which has been previously integrated into core budgets for health boards and local authorities.

<u>Independent Professional Advocacy (IPA) & Statutory Advocacy for Children and Young People</u>

Welsh Government provides a grant to local authorities for Statutory Advocacy for children and young people which is provided by Independent Professional Advocates. It also provides a small grant direct to a provider to support the provision of Wales-wide statistics relating to the National Approach to Statutory Advocacy for children and young people.
