## Request for information - ATISN 19212

Thank you for your request which I received on 25 October.

### **Your Request**

You asked for the following information regarding the regular flooding in the village of Tyn Llan Farm, 21-24 Tyn Llan and 2-10 Cae Derwen (post code CH7 5SX).

The information required on the A494 Trunk Road Llanferres project:

- 1. Dates for all stages of the project from inception to completion / opening of the road.
- 2. Planning permissions (national and local)
- 3. Objections raised by individuals or organisations
- 4. Detailed design documents / plans, especially for drains, culverts, watercourses
- 5. Any photographic evidence BEFORE the project started
- 6. Risk assessments and mitigations relating to drains, culverts, water courses
- 7. Any other documents you consider to be relevant for an issue of flooding

#### **Our Response**

I can confirm that the Welsh Government does not hold the information you have requested. The only drawings we have on file within that area are (pre-Clwyd CC) Denbighshire County Council and County of Denbigh bridge drawings for Pont Y Cacwn. These drawings are attached.

The scheme in question is likely to have been delivered by Clwyd County Council on behalf of the Welsh Office as it pre-dates Local Government reorganisation in 1996. This would have been through their Trunk Road design teams and whichever contractor was appointed.
