Dear Rt Hon. Lord Goldsmith of Richmond Park

Thank you for your recent response to my letter to you on this important issue (Our ref: LG/230/20, your ref: MC2020/16377/EC).

I have also previously written to The Rt Hon. Amber Rudd, then Home Secretary, in 2017 (ref: DC-LG-01014-17), and to Lord Gardiner of Kimble, Parliamentary Under Secretary of State for Rural Affairs and Biosecurity, in 2018 (Your ref: PO2017/11464/MP /Our ref: IM/LG/00396/18), on this matter.

As you are aware, the reserved nature of The Dogs (Protection of Livestock) Act 1953 prevents the Welsh Government from implementing the recommendations outlined in my previous letter, which were put forth following engagement with the National Police Chiefs' Council and the All-Party Parliamentary Group on Animal Welfare on the matter.

I therefore very much welcome the news from your correspondence that work is now underway to explore legislative changes needed to best address the problem of livestock worrying.

You note that in addition to the National Police Chiefs' Council and the All-Party Parliamentary Group on Animal Welfare, your officials have also been engaging with ours to understand fully the Welsh perspective on proposed policy options, and engagement on this to date has been much appreciated.

We both share concerns about the devastating impact these attacks can cause to both the animals involved, from a welfare perspective, and also to the farming community.
