Dear Suella

You will be aware of the disturbing reports of fatalities and serious injuries recently on children and adults as a result of dog attacks in the UK. Sadly, here in Wales, this included the death of 10-year-old Jack Lis in November 2021 who was attacked by a dog at a friend's home in Caerphilly.

I welcome DEFRA and Welsh Government officials working together on the Responsible Ownership Working Group which is considering the recommendations of our jointly funded research into dog attacks.

Perceived shortcomings of the Dangerous Dogs Act 1991 (DDA) have recently been raised by Members of the Senedd, particularly in relation to the prohibited breed list contained within the Regulations. Whilst it has always been my stance any dog has the potential to cause harm and show aggression, there does appear to be a disproportionate number of incidents involving American XL Bully breeds.

As recommended in the research paper, AW140: Investigation of measures to reduce dog attacks and promote responsible ownership amongst dog owners with dog control issues in the UK, can you provide assurance of how effective preventative measures, available to police officers under the Anti-social Crime and Policing Act 2014, are being taken?

In addition, can you confirm which measures you are taking to improve records of dog attack data in the UK?
