The A470 Trunk Road (South of
Upper Boat Junction, Pontypridd,
Rhondda Cynon Taf) (Temporary
Prohibition of Vehicles) Order
2024

Made 26 January 2024

Coming into force 1 February 2024

The Welsh Ministers, as traffic authority for the A470 trunk road, are satisfied that traffic on specified lengths of the trunk road should be prohibited because of works proposed on or near the road.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by sections 14(1) and (4) of the Road Traffic Regulation Act 1984(1), make this Order.

Title and commencement

1. The title of this Order is the A470 Trunk Road (South of Upper Boat Junction, Pontypridd, Rhondda Cynon Taf) (Temporary Prohibition of Vehicles) Order 2024 and this Order comes into force on 1 February 2024.

Interpretation

2. In this Order—

(1) 1984 c. 27; section 14 was substituted by the Road Traffic (Temporary Restrictions) Act 1991 (c. 26), section 1(1) and Schedule 1. By virtue of S.I. 1999/672, and section 162 of, and paragraph 30 of Schedule 11 to, the Government of Wales Act 2006 (c. 32), these functions are now exercisable by the Welsh Ministers in relation to Wales.

ystyr “cyfnod y gwaith” (“*works period*”) yw’r cyfnod sy’n dechrau am 20:00 o’r gloch ar 1 Chwefror 2024 ac sy’n dod i ben pan gaiff yr arwyddion traffig dros dro eu symud ymaith yn barhaol;

ystyr “y gefnffordd” (“*the trunk road*”) yw cefnffordd yr A470 Caerdydd i Langurig.

Gwaharddiad

3. Ni chaiff neb, yn ystod cyfnod y gwaith, yrru unrhyw gerbyd ar y darnau o’r gefnffordd a bennir yn yr Atodlen i’r Gorchymyn hwn.

Cymhwyso

4. Nid yw’r gwaharddiad yn erthygl 3 yn gymwys ond ar yr adegau hynny ac i’r graddau hynny y bydd arwyddion traffig yn eu dangos.

5. Bydd y Gorchymyn hwn yn para am 18 mis ar y mwyaf.

YR ATODLEN

Y darn o’r llain galed sy’n gyfagos i gerbyffordd tua’r gogledd y gefnffordd sy’n ymestyn o bwynt 1.12 cilometr i’r gogledd o ganolbwynt ei chyffordd â’r A4054 a’r A468, hyd at ddechrau’r ffordd ymadael tua’r gogledd wrth Gyffordd Glan-bad, Pontypridd, Rhondda Cynon Taf.

Y darn o gilfan gyfagos i gerbyffordd tua’r gogledd y gefnffordd, a leolir 1.2 cilometr i’r gogledd o ganolbwynt cyffordd yr A470 â’r A4054 a’r A468.

“the trunk road” (“*y gefnffordd*”) means the A470 Cardiff to Llangurig trunk road;

“works period” (“*cyfnod y gwaith*”) means the period commencing at 20:00 hours on 1 February 2024 and ending when the temporary traffic signs are permanently removed.

Prohibition

3. No person may, during the works period, drive any vehicle on the lengths of the trunk road specified in the Schedule to this Order.

Application

4. The prohibition in article 3 applies only during such times and to such extent as indicated by traffic signs.

Duration of this Order

5. The maximum duration of this Order is 18 months.

SCHEDULE

The length of the hard shoulder adjacent to the northbound carriageway of the trunk road that extends from a point 1.12 kilometres north of the centre-point of its junction with the A4054 and A468 to the start of the northbound exit slip road at Upper Boat Junction, Pontypridd, Rhondda Cynon Taf.

The length of lay-by adjacent to the northbound carriageway of the trunk road, which is located 1.2 kilometres north of the centre-point of the A470/A4054/A468 junction.
