

**Distribution Sub-Group (2022) Paper 08 –
Population data Census 2021 for the 2023-24 Settlement**

This discussion paper has been written by officials of the Welsh Government. Ministers have not had an opportunity to comment on the contents. Exemplifications of changes are provided simply to inform discussion by DSG members. They are not Welsh Government proposals or statements of Government policy for or against changes.

Population data for the 2023-24 settlement

Summary

1. Following the publication of the 2021 census population age breakdowns, this paper assesses the population data to be used within the 2023-24 local government settlement.

Views sought

2. DSG are asked to discuss the population data presented within this paper and agree the most appropriate dataset to be used in the 2023-24 settlement.

Background

6. Population data is used across the UK by national and local government to plan and fund services. The most authoritative population estimates are derived from the census, which takes place every 10 years in the UK. More information on the background can be found in *Distribution Sub-Group (2022) Paper 05 – Population data for the 2023-24 settlement*.
7. The latest published [Demography and migration in Wales \(Census 2021\)](#) was published on 2nd November 2022, this includes unrounded population and household estimates published on [StatsWales](#).

Current Analysis

8. Previously the DSG had agreed to use a hybrid of the available 2021 Census population data and the 2018-based population projections for 2023 and provide DSG the financial implications as soon as the further population age breakdowns become available.
9. The following section will now investigate the full financial implications of using all the unrounded population Census 2021 data for the 2023-24 settlement. These population indicators will contribute all SSA associated with the pure population data. In particular they are used in the IBAs listed in table 7 in ANNEX C.

Census 2021 and population projections 2023

10. Table 1 and table 2 shows the Census 2021 population estimates and the 2018-based population projections for 2023 for information.

11. Table 3 in Annex A shows the difference in population between the Census 2021 and the 2018-based population projections for 2023. The most notable differences can be seen in Swansea and Gwynedd where the Census 2021 population estimates are significantly lower than the 2018-based population projections for 2023. In contrast, Census 2021 population estimates for Ceredigion, Powys and Newport are greater than the 2018-based population projections for 2023.
12. Table 4 in Annex A considers the relative change of main settlement population indicators of population numbers from 2021 Census compared to 2023 Population Projections.

Re-distributional effect

13. Table 5 in Annex B is an extended analysis of the *Distribution Sub-Group (2022) Paper 05 – Population data for the 2023-24 settlement*. It analyses and compares the re-distributive financial impact of using the full unrounded Census 2021 population data.
14. By using all the Census 2021 population data for the 2023-24 settlement, Newport, Powys and Carmarthenshire have the largest monetary increases of £2,565k (1.0%), £1,621k (0.8%) and £1,468K (0.5%) respectively. The largest monetary decreases can be seen in Gwynedd and Swansea with decreases of £3,192k (1.5%) and £3,032 (0.8%) respectively.
15. By applying the full Census 2021 population data we can see significant financial implications. Table 6 in Annex B considers options of dampening these financial impacts and are explained in options i) – iii).

Discussion

16. DSG are asked to consider the current population projections data and the effects of applying the Census 2021 data.
17. In the last meeting DSG agreed to use a hybrid of the 2018-based population projections for 2023 together with the available elements of the 2021 population Census data. This analysis is displayed in table 5.
18. DSG are now asked to consider the following three options in the use of population data for the 2023-24 settlement and agree the most appropriate option to take. The analysis is displayed in table 6:
 - i) Use all the 2021 Census population data for 2023-24 settlement. This will use the most up to date accurate population data and set us up to use 2022 mid-year estimates for the 2024-25 settlement and 2021-based population projections for the 2025-26 settlement. Recommend that the Government applies floor funding where necessary.
 - ii) Use all the 2021 Census population data for 2023-24 settlement. Consider the isolated difference as a result of the Census population age breakdown data, taking 50% of the financial impact then add that value to the settlement distribution. This will dampen any significant financial implications before using datasets from 2021 Census population data in future settlements.
 - iii) Use all the 2021 Census population data and all the 2018-based population projections for 2023 and take an average of the population to use within the model. This will dampen any significant financial implications before transitioning to population datasets used in future settlements.

Population data for future settlements

19. The release date for [2021 mid-year population estimates](#) will be based on the 2021 census and will be published in December 2022, hence will be too late to use in the 2023-24 settlement. The release date for 2022 mid-year population estimates will be based on the 2021 census and will likely be published in Autumn 2023. 2021-based subnational population projections will be published in Spring 2024. Hence analysis for the 2024-25 settlement could use 2022 mid-year estimates and the 2025-26 settlement could use 2021-based population projections for the year 2025.
