The technical data which support figure 21 within Net Zero Wales Carbon Budget 2 (2021-2025), specifically on what emissions are included in the supporting data set.

## Our response

I have decided that the information is exempt from disclosure under section 21 - Information accessible to applicant by other means - of the Freedom of Information Act.

The data Figure 21 within Net Zero Wales Carbon Budget 2 is drawn from is sourced from the Greenhouse Gas Inventories for England, Scotland, Wales & Northern Ireland: 1990-2019 and aligned to the Welsh Government sectoral definition and described in Annex 4. You can find the 1990-2019 DA GHGI Dataset here Report: Greenhouse Gas Inventories for England, Scotland, Wales & Northern Ireland: 1990-2019 - NAEI, UK (beis.gov.uk) and choose the "By Source Wales" tab.

Further, to produce Figure 21 category conversion was applied, from GHGI's IPCC categories to the Welsh Government categorisation.
