Mae Gweinidogion Cymru yn bwriadu gwneud Gorchymyn drwy arfer eu pwerau o dan adrannau 84(1)(a), 84(2) a 124(1)(d) o Ddeddf Rheoleiddio Traffig Ffyrdd 1984, a pharagraff 27 o Atodlen 9 iddi.

Effaith y Gorchymyn arfaethedig fydd cyflwyno terfyn cyflymder o 40 mya ar y darnau o'r gefnffordd a bennir yn yr Atodlen i'r Hysbysiad hwn.

Bydd Gorchymyn Cefnffordd yr A40 (Narberth Road a Fishguard Road, Hwlffordd, Sir Benfro) (Terfyn Cyflymder 40 mya) 2013 (O.S. 2013/2507 (Cy.246)) yn cael ei ddirymu gan y Gorchymyn arfaethedig. Bydd Gorchymyn Cefnffordd yr A40 (Hwlffordd, Sir Benfro) (Terfynau Cyflymder 40 mya a 50 mya a Dileu Cyfyngiadau) 2018 (O.S. 2018/941 (Cy.185)) yn cael ei amrywio gan y Gorchymyn arfaethedig.

**THE A40 TRUNK ROAD  
(HAVERFORDWEST, PEMBROKESHIRE)  
(40 MPH SPEED LIMIT) ORDER 202-**

The Welsh Ministers propose to make an Order in exercise of their powers under sections 84(1)(a), 84(2) and 124(1)(d) of, and paragraph 27 of Schedule 9 to, the Road Traffic Regulation Act 1984.

The effect of the proposed Order will be to introduce a 40 mph speed limit on the lengths of the trunk road specified in the Schedule to this Notice.

The A40 Trunk Road (Narberth Road and Fishguard Road, Haverfordwest, Pembrokeshire) (40 mph Speed Limit) Order 2013 (S.I. 2013/2507 (W. 246)) will be revoked by the proposed Order. The A40 Trunk Road (Haverfordwest, Pembrokeshire) (40 mph & 50 mph Speed Limits and Derestriction) Order 2018 (S.I. 2018/941 (W. 185)) will be varied by the proposed Order.

During a period of 21 days from 27 March 2024 a copy of the proposed Order, the Statement of Reasons for making the Order, the plan and the Orders being revoked and varied may be inspected, free of charge, at the offices of Pembrokeshire County Council, County Hall, Haverfordwest SA61 1TP.

#### **SCHEDULE**

The circulatory carriageway of Scotchwell Roundabout, Haverfordwest.

The length of the trunk road that extends from its junction with the western side of the circulatory carriageway of Scotchwell Roundabout, Haverfordwest to a point 287 metres west of that junction.

The length of the trunk road that extends from its junction with the eastern side of the circulatory carriageway of Scotchwell Roundabout, Haverfordwest to a point 724 metres east of that junction.

The length of the trunk road that extends from its junction with the northern side of the circulatory carriageway of Scotchwell Roundabout, Haverfordwest to a point 235 metres north of that junction.
