

**GORCHYMYN CEFNFFORDD YR A470
(SOUTH STREET, RHAEDR GWY, POWYS)
(GWAHARDD CERBYDAU A BEICWYR DROS
DRO) 2024**

Mae Gweinidogion Cymru wedi gwneud Gorchymyn o dan adran 14 o Ddeddf Rheoleiddio Traffig Ffyrdd 1984. Mae angen y Gorchymyn er mwyn gwneud gwaith ar gefnffordd yr A470, neu gerllaw iddi, yn Rhaeadr Gwy, Powys.

Effaith y Gorchymyn yw gwahardd dros dro bob cerbyd a phob beiciwr rhag mynd ar y darn o gefnffordd yr A470 o'r enw South Street, Rhaeadr Gwy sy'n ymestyn o bwynt 10 metr i'r gogledd-orllewin o ganolbwynt ei chyffordd â'r ffordd sy'n arwain at Ystad Bryn Gwy hyd at ei chyffordd â'r A44 Stryd y Dwyrain.

Y llwybr arall ar gyfer traffig sy'n teithio tua'r gogledd yw mynd ar yr A470 tua'r de, yr A4081 tua'r dwyrain i Landrindod, tua'r gogledd drwy Barc Menter Ddole Road, yr A483 tua'r gogledd i'r Groes a'r A44 tua'r gorllewin i Raeadr Gwy: i'r gwrthwyneb ar gyfer traffig sy'n teithio tua'r de. Yn Rhaeadr Gwy, caiff cerbydau LGV eu cyfeirio i fynd ar hyd Gerddi Gleision, y Lôn Dywyll a'r B4518 i ailymuno â'r A470 i'r gogledd o'r darn o'r gefnffordd sydd wedi ei gau.

Dylai cerbydau ag ochrau uchel dros 14' sy'n teithio tua'r gogledd fynd ar yr A470 tua'r de, yr A4081 tua'r gorllewin i Lanllŷr a Gravel Road tua'r gogledd-ddwyrain i ymuno â'r A44 tua'r dwyrain i Raeadr Gwy: i'r gwrthwyneb ar gyfer cerbydau sy'n teithio tua'r de.

Daw'r Gorchymyn i rym ar 14 Mawrth 2024. Disgwylir y bydd y gwaharddiadau dros dro yn weithredol o 19:00 o'r gloch ar 14 Mawrth hyd 06:00 o'r gloch ar 15 Mawrth 2024 neu hyd nes y caiff yr arwyddion traffig dros dro eu symud ymaith yn barhaol.

Dim ond yn ystod y cyfnod a bennir uchod y disgwylir i'r Gorchymyn fod yn weithredol. Er hynny, bydd yn parhau'n ddilys am gyfnod o 12 mis ar y mwyaf rhag ofn y bydd angen ail-amserlennu'r gwaith neu wneud gwaith canlyniadol neu waith arall. Bydd hysbysiad ymlaen llaw am unrhyw newidiadau i'r amseroedd a'r dyddiadau yn cael ei arddangos cyn gwneud unrhyw waith a ailamserlennir.

**THE A470 TRUNK ROAD (SOUTH STREET,
RHAYADER, POWYS) (TEMPORARY
PROHIBITION OF VEHICLES & CYCLISTS)
ORDER 2024**

The Welsh Ministers have made an Order under section 14 of the Road Traffic Regulation Act 1984, which is necessary to undertake works on or near the A470 trunk road at Rhayader, Powys.

The effect of the Order is to temporarily prohibit all vehicles and cyclists from proceeding on the length of the A470 trunk road known as South Street, Rhayader that extends from a point 10 metres north-west of the centre-point of its junction with the road leading to Bryn Gwy Estate to its junction with the A44 East Street.

The alternative route for northbound traffic is via the southbound A470, eastbound A4081 to Llandrindod Wells, northbound through Ddole Road Enterprise Park, northbound A483 to Crossgates and westbound A44 to Rhayader: vice versa for southbound traffic. In Rhayader, LGVs will be routed via Green Gardens, Dark Lane and the B4518 to rejoin the A470 north of the closure.

Northbound high-sided vehicles over 14' should take the southbound A470, westbound A4081 to Llanyre and north-eastbound Gravel Road to join the eastbound A44 to Rhayader: vice versa for southbound vehicles.

The Order comes into force on 14 March 2024. The temporary prohibitions are expected to operate from 19:00 on 14 March until 06:00 hours on 15 March 2024, or until the temporary traffic signs are permanently removed.

Although the Order is only expected to be in force during the period specified above it will remain valid for a maximum period of 12 months, as a contingency, should the work need to be rescheduled or consequential or other work is required. Advance notice of any changes to times and dates will be displayed before any rescheduled work.
