You asked for the following information regarding the M48 and A40:.


- 1) the risk assessments that were used to make this decision.

3) We do not have the expected costs for repairing the barriers. These will not be reached until the feasibility studies are undertaken. The feasibility studies are not included in the FY24/25 programme due to other competing budget pressures.
