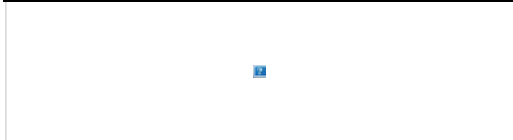

I wonder if you could assist please. Sam and I had a meeting with ERI and [REDACTED] today about the Bedwas tip. They mentioned correspondence with NRW [REDACTED] and they sent on the email from [REDACTED]

The email mentions 'Welsh Government is in the process of producing a new policy specifically relating to tip restoration which we have been advised will be available towards the end of 2023.

We were a bit surprised about this as we are not producing a policy specifically relating to tip restoration.

I was wondering if what was meant by this was the Protocol – which of course deals with very different types of work and is very much in relation to necessary works on tips.

Would you be in a position to clarify please? It is quite difficult in a meeting to be informed that we will be introducing a policy very soon, when we know that no policy exists and it leads to confusion. If it is the Protocol – it would be good if [REDACTED] and others could be made aware that this is not in relation to tip restoration and is not a policy but a collaborative working approach between WG, NRW, WLGA and CA. It would also be good if [REDACTED] could follow up with those in the email below to correct the situation.

Good afternoon [REDACTED]

Your recent renewed interest in the Bedwas Tip project has been discussed at a high level within NRW in the context of the controversial theme of coal extraction for energy and how that fits with NRW's new Corporate Plan. It is fair to say that there has been some concern because of the coal removal element of the project.

However, NRW understands that the Welsh Government is in the process of producing a new policy specifically relating to tip restoration which we have been advised will be available towards the end of 2023.

Therefore, NRW will await the outcome of this policy before taking the project through our Governance procedures. In the meantime, if you wish to continue your survey of the road we are content for you to carry on with that, but please understand that any approval for an Access Permission to survey the road does not imply any approval by NRW for the use of the road for the restoration of the tip.

I will keep you up to date on any developments.
